# Bloodiest Encounter of the Pacific War Written By Robert Leibold

I'm currently poring through more than forty books and hundreds of pages of battle action reports in an effort to research and better understand the battle for Okinawa, America's bloodiest-and least heralded-campaign of the Pacific War. What I'm steadily coming to realize is that Okinawa is less a single battle than a hundred vicious struggles wrapped into one, a sprawling, titanic battle which perhaps marks the scene of our armed forces' greatest combined effort of World War II, and perhaps our greatest hour of that war. With the increasing media publicity surrounding the heroic capture of tiny Iwo Jima and it's celebrated flag raising, I'm continually amazed that more Americans aren't inclined to take a closer look at Okinawa, a battle that indeed makes Iwo pale in comparison. With newspapers and Internet sites filled to the brim these days with photographs of mighty Mount Suribachi, I went browsing for similar photographs of Okinawa's Hill 50.2, a seemingly innocuous bump on the ground located just beyond the Asa River, in what was once known as "Target Area 7672George." That tiny bump, I was told by my First Marine Division father nearly fifty years ago, cost the lives and limbs of untold thousands of Marines and Japanese. "The final capture of Sugar Loaf," my father had noted, "had cost two countries thousands more men than were expended in the fight for Iwo's Suribachi, and the darkest thing of all is, battles like Sugar Loaf were to be repeated scores of times on Okinawa-over and over again."

In a search for modern-day photos, I happened on your and was appalled at what the Okinawans have since done to Sugar Loaf, site of one of the most noteworthy struggles in Marine Corps history. To survivors of Sugar Loaf-and to survivors of Okinawa nationwide-I say God bless all of you, and thank you.

#### **Association Funds**

Harold Howell, as president at that time, changed accounting procedures in a letter to the Executive Board September 7. Portions of that letter are reproduced below.

"Some time ago, to simplify association bookkeeping, we established that, in general, funds received would be assigned to the General Fund.

"The exceptions to that assignment would be restricted to special specific activities as designated by the individual making the offering.

"Unfortunately, over the past two years, there have been some misdirected contributions which could reflect poorly upon the Association. Specifically, a contribution made to the Scholarship Fund in memory of Harry Simes, one of our founders, by his daughter has not been forwarded to that body. There are others. In addition, those who have made such contributions may have claimed a tax deduction; an action the Association faulted by not properly responding to the designated action.

The other complimentary rooms 1 for every 50 guests registered. On a non cumulative basis, which means if you do not have 50 on any night you get no rooms comped. # HISTORIAN'S CORNER

Another role that the "greatest generation" has played has been to serve their communities both actively and as role models. Recently I was told no other generation has volunteered as much. Toys for Tots was started by Marine reservists in 1947 – I'm sure participants from WWII

I was the product of the Depression and the Dust Bowl, a Kansas boy, who watched the boys of WWII go off to battle and return home. Like all of our neighbors, my family

knew what it was to do without, yet relatively speaking we did all right. We had a roof over our head and after my Dad lost his farm he was able to find work as a caretaker for a cemetery and later worked in a local munitions factory. There were those who needed more than we did and those who had more.

In high school as a freshman who lived out from town I would often wait by the road hoping someone would offer me a ride to school. I found a steady ride with a girl a few years older than myself, who would often stop and pick me and my cousin up in the mornings. I was awed by her; she was older and neat as a pin, so other than 'thank you' few words were exchanged.

My town was one of the many WWII towns that had an airbase, the Olathe Air Station, and from an early age I was fascinated with the military men, especially the Marines associated with the base. As a teenager I joined the reserves at the base and as part of the reserve unit VMF-215 was required to help the Marines deliver Toys for Tots. At that time the toys were seldom new but instead were used toys that had been refurbished by the local firemen. It is always both a gratifying and sobering experience, to see the delight on the children who without the help of the community and the Corps would have so little for the holidays.

It was almost dark as we made the drive down a long dirt drive to a house that had seen better days. It was filled to the brim with multi-generations of children. The father had been badly hurt in a farming accident and one daughter and her children were also in residence. The children squealed with delight, "new" bikes and baby dolls insured children of a Merry Christmas and the understanding that they mattered. In the shadows smiling at her younger siblings was a neat as a pin, quiet junior from Olathe High School---my ride.

I quietly returned to the truck not wanting her to see me and possibly be embarrassed, hiding my own shame at having sponged a ride for so long from someone who had less than me. Yet, also understanding the difference that Marines make when for a short time every year they lay down their warrior mantles and become Santa to thousands of children.

A year never passes that I do not think of that family, in dire straights, that young generous girl and the bounty that the Marine Corps brings. It is probably one of the reasons I became a Marine and send my financial contribution every August. This program which began in 1947 makes a difference in many lives—I know.

# **Directors Meeting Minutes**

At the request of Chaplain Frank Mack, the representative of the Sons and Daughters was invited to address the Directors prior to the meeting. She restated the message previously given by Jean Steed—Essentially, that the youth are ready to aid and assist the Association in any way, but we must let them know where and how.

President Howell opened the meeting by asking the Chaplain to give the invocation.

President-elect Essex led the body in reciting the Pledge of Allegiance.

The roll call of Officers and Directors was called by the Secretary. The reading of the minutes of the previous meeting was not required since they were published in the Newsletter. The reports of the officers were called for by President Howell. President –elect Essex had no report to give.

Secretary Terpinas reported that although he had the recorder, it probably was not functional. He added that he would attempt to make notes as the meeting proceeded and make available the essence of business as he was able to recall. Treasurer McConville reported the status of the General Fund as of 09/01/2006 (\$38,109.89), and the Overflow Account as of 09/2006 (\$63,930.18)

Because the President could not access his e-mail, the Editor's report was not given. The request of the Directory Chair for additional funds was presented to the body and approval for an additional \$3,000.00 was proposed and passed, providing for a total funding of \$7500.00.

Judge Advocate Petriello reported on a proposed by-laws change to allow a proportional regular membership to Sons and Daughters having served in the military services. He also reported on the granting of scholarships to descendants of our members in the amount of \$36,750.00 for the 2006-2007 academic years.

Public Relations Chair Pierce reported on his activities of the year, as well as the status of the painting of Sugar Loaf Hill and the plaque to be attached to the frame when presented to the Marine Corps Museum in Quantico in 2007.


Service Officer Sproatt was unable to be present, but had sent his stock of Urn Markers to be made available as decided by the Body. Immediate Past President Sinatra served as Sgt. At Arms for the meetings, and performed his duties admirably.

President Howell presented an agenda which asked the body to consider and approve: Condition of the Quantico Memorial and the need to provide for maintenance and repair, renewal of Membership Manager Agreement. This was approved with an increase of \$35.00 monthly effective 11/01/2006.

Another portion of the agenda was the authorization of payments to entities designated by Member et al (scholarships, Directory), which was also approved and the Treasurer prepared a check to Marine Corps Scholarship Foundation and the format of newsletter last page to delete scholarship donation and direct such donations be mailed directly to *mcfs*, *Trenton*, *NJ* 

There was an orderly election of Unit Directors prior to General Meeting. Officers' reports were prepared in writing and given to Secretary Terpinas.





Sir: I read with great interest the article On Page 12 of the latest issue of the Striking Sixth newsletter regarding the Marine on Sugar Loaf Hill. I was in C Co., 6th Tank Bn. During the battle of Okinawa I was principally a tank gunner. During the action at Sugar Loaf our tank was approached by an individual who contacted us via telephone on the outside rear of our tank.

He informed me that he was going up the hill to look around and requested covering fire. He then went around to the front of our tank and appeared in my gun sight. I observed him to be armed with a B.A.R. and .45 automatic holstered on his hip. He began his assent up the hill while I fired my .30

co ax machine gun approximately 4-5 feet over his head. I ceased firing when he was near the crest and continued observing him in my gun sight. He walked along the crest firing the B.A.R. Apparently he used up the ammo as he ceased firing and drew his .45, fired several rounds and then ran pell-mell down the hill toward our tank.

# Kazian Essay on Sixth Officer Makes'Military' Magazine

Leon H. Kazian, C-1-4, has written an essay extolling Lt. Col. Harold C. Roberts, who was then serving as C.O. of the 18th AAA Battalion, an outfit that also claimed Kazian before he joined the 4th Marines. The essay was published in "Military" magazine.

Apparently Roberts was an enlisted Marines' officer, who thought nothing of sending his troops through the chow lines while holding his officers back. He also was to be found, shirt off, loading ship and doing other things that endeared him to his men. Serving later with the Sixth Division's 22nd Regiment, Roberts fell victim to a sniper on June 18 at Hill 69.

In Kazian's words, "Col. Roberts had served God, flag and country in WWI, WWII and had been awarded three Navy Crosses in addition to other awards and commendations. He exemplified the words, 'First in war and first in peace' within the hearts of his fellow Leathernecks and will be remembered by his men as a gentleman and real Marine."



#### **BOOK REVIEW: The Timid Marine**

This book of fiction is apparently autobiographical. Written by Joseph Lanciotti, perhaps of the Third Battalion, 29th (that was never made clear), it covers the trials and difficulties of a "combat fatigued" Marine on Okinawa.

This reviewer was going to give it a paragraph at best once I learned that the protagonist was a high school dropout poet. That's enough in itself to anticipate imminent psychosis. There turned out to be more to the book than I expected from this unenthusiastic draftee with an attitude.

To set the scene, the writer allows that he was just a poor kid from Jersey whose draft number came up. He wasn't sure why he then volunteered for the Marine Corps, apparently a bad decision.

After an unfortunate tour at the Boston Navy Yard, he headed overseas on the Sea Bass, destination Guadalcanal and the Sixth Division. The landing on Okinawa is as confusing to the reader as it apparently was to our tormented Marine. From here on until late June it is blood and guts without relief. To give credit where due, the writer is more than candid; you know he's telling you exactly how he felt about the whole thing.

Sugar Loaf (again not quite clear) was too much for a lot of people, including "Lance." He joined the crowd heading for the rear. He admits his fear and disgust after 60 years in a published novel, this reviewer believes, because he considered it a justifiably rational act. Apparently, cowardice was not really a factor, he just had enough of the "Butcher Shop," though he did return to the line later and fought until the end.

His views of China were just as gritty. He tells how it was if you looked critically at the society that surrounded the troops there. He did find relief from self-righteousness in friendships with Russian and Chinese residents of Tsingtao, made in part through his desire to learn the Chinese language.

The book has value. The writer bares it all. He deserves credit for that, but you have to get past the misspellings, grammatical errors, some awkward phraseology and, above all, the aforementioned attitude. Lanciotti also wrote "River Island." During the 82-day battle for Okinawa the 4 army and 2 Marine Divisions experienced a total of 26,211 non-battle casualties. This is interesting as that totals out to be (in numbers) one division! With 7,373 killed and another 31,807 wounded that totals another 2 divisions. Some wounded did return to their respective divisions as we know. But that still totals out to be almost 3 divisions! That is a very high amount of combat men to be lost in just an 82 day period. One wonders what landing in Japan would have been like.

Also interesting is that of the non-battle casualties, the 1st Marine Division had the most with 5,101, which is one fourth of a division! The 7th Army Division suffered the second highest with 4,825, the 6th Marine Division with 4,489 was the third highest.

Another interesting stat is that the 2nd Marine Division had more men MIA (Missing in Action) then any other Division. This is due no doubt to the loss of men when a Kamikaze slammed into their LST during the feint or fake landing on April one.


