Reunion Rain Sets Stage for Memorial

NORFOLK, Va. (Oct. 15, 2007) --On April 1, 1945, 6th Marine the Division took part in the Battle of Okinawa, the bloodiest land battle of the Pacific war. The 6th MarDiv suffered nearly 1,700

casualties (deaths, actually) and more than 7,400 were wounded in action. The Sixth Marine Division Association held their (not quite) final national reunion with various events Oct. 9-14, here to commemorate the battle they and their fellow Marines so bravely fought over 62 years ago.

The memorial service and wreath laying ceremony by Gen. Carl B. Jensen, John Foley and Bill Pierce on the USS Wisconsin was the first main event of the week.

As the skies wept their tears, it reminded many veterans of the first gruesome 18days (actually later) of the assault. Many would consider rain to be a hindrance at

a memorial, but to some Marines here it was a fitting way to say goodbye to their fellow brothers.

Rev. Frank J. Mack, the Sixth Marine Division Association's chaplain and ceremony narrator, spoke of the importance for Marines and Americans to carry on the history of WWII.

"The battles we fought will be taught in schools and we will remain in text books, but it is up to our remaining members and...

their families and friends to carry on our memories. For when the final flag is folded, WWII will only be a distant memory. We must never forget the gallant warriors we knew," said Mack.

After the final role was called and the muster bell rung for all the association members who have perished over the past few years (last year only), members tied ribbons to the ceremony wreath before it was laid into the water.

With the final ribbon tied, the 6th MarDiv wreath was cast over the edge of the ship, and final thoughts and words were said in remembrance. "Bless the brave souls that have given up their tomorrows so we could have our todays," said Mack.

Although the memorial service started off the week-long reunion in a somber mood by paying respects, the following day immortalized these Marines with a dedication ceremony.

The Joint Forces Staff College hosted the association members outside Okinawa Hall library here to dedicate a print of "The Battle for Sugar Loaf Hill." The print depicts the Marines that courageously gave their lives, nearly 3,000 (not that many) to secure the well-defended hill on Okinawa that was essential to capture.

Before the dedication ceremony, the association members had a chance to meet Marines attached to 3rd Fleet Anti-Terrorism Security Team Company, who displayed various weapons, riot gear and a Humvee. The library was also opened to the members with a display of WWII history and an assortment of weapons used during the war.

After the members had a chance to talk with 3rd FAST Marines and tour the library, the print was dedicated to the college. Jeanne McDonnell, the college's chief of staff, accepted the framed print of "The Battle for Sugar Loaf Hill."

"It is an honor to have this picture dedicated to the college and it is a pleasure to hang this piece on the wall in Okinawa Hall," said McDonnell after accepting the print.

Following the dedication, association members and active-duty Marines walked across the street to talk and exchange stories during lunch at Marianas Hall.

The association concluded this event-filled reunion with a banquet as its final farewell, instilling in the members the effect they had on the Corps.

"Although Marines of today may have changed in many ways, one important thing that hasn't changed is the same spirit of sacrifice," said Cmdr. Stephen P. Beyer, the Norfolk Naval Base command chaplain and a reunion guest speaker. "When you ask a Marine why he chose the Marines, the answer 60 years ago is the same as it is today, 'because I want to serve my country."

This may be the final (We're not done yet.) national reunion for the association, but the members will forever have a lasting effect on the Marines of today and the Marines of the future.


SUGAR LOAF PAINTING DELIVERED TO TEXAS

I was especially pleased to see the photograph in one of the articles, which depicted my brother with you and other Marines. Actually, this particular photograph is the only non-posed photo (other than a few childhood pictures) I have ever seen of my brother! To me, this was a real big deal! Buford. **Ed's Note**: Watson Crumbie, C-1-29, also corresponded with Buford.

Billy Cates Reported Killed. Marine Corp. Billy Byers Cates has been reported killed in action on Okinawa, his father, Buford A. Cates, 5501 Stanford, has learned. He was a gradate of wood-Wilson row High School and had completed one semester at the University o f Texas when he Cates enlisted in the marine corps. Following his "boot" and line training at San Diego, he was sent overseas in 1943.

After receiving battle wounds during the invasion of Saipan, he was sent to Guadalcanal to re-cuperate. When recovered, he was transferred to the Sixth Division

and sent to Okinawa.



Just opened my mailbox and the Nov. issue of WWII was there. It's got an 8page article on Sugar Loaf, by Bill Sloan, author of the upcoming book, "The Ultimate Battle." 
<u>Judge Advocate</u> –Nominated and moved to accept by acclamation Sam Petriello who accepted the nomination, seconded by Mr. Volje.

The 22nd Marines met to elect a new Director. James May was elected.

Old Business:

Directory: Mr. Marsalek stated that the Board of Directors recommended that a new Directory be approved at a cost of up to \$7500. Jim White, seconded by Charles Monnett, moved to accept the bid to print the directory and mail it at a cost of up to \$7500. Mr. Terpinas showed how the directory would look. It is in a 3 ring binder format and people can put it in their own binders. This format would make it easy to update. It would be sent to all members after it has been updated as of January 1, 2008. Discussion was held on how often the updates should be done. George Hettinger, seconded by Andy Horvath moved to have annual updates. All in favor, motion carried. Sons and Daughters: President Essex reported that there is a proposed by-law change that the Board of Directors recommends that the Sons and Daughters have the right to hold an office and have voting privileges in the Sixth Marine Division Association. He asked for a motion to approve the recommendation of the Board to give the Sons and Daughters full regular membership in the Association.

Mr. Foley mentioned that the federal tax status of the Association requires that 90% of the members be military veterans. 10% can be wives and friends. If this proposal is passed then the tax status becomes null and void as does the corporate account with the State of New Jersey.

Mr. Petriello reported that something has to be done in order for the Association to continue. This proposal was made to include the sons and daughters as full members. Under 501(c)(19) of the IRS Code, 97.5% of the group must be in the military or be veterans. This leaves 2.5% for non-veterans. Some of the sons and daughters are military veterans. So some others can be brought in. The Association needs help. It can dissolve and just meet without all the formality. One place could be chosen for every

year. If not, something else needs to be done. Maybe it would not be tax exempt, but it would be non-profit. Many other organizations have been around for many, many years. If sons and daughters are not brought in, after three years when the current officers are finished with

their terms, he doesn't know what will happen. Reverend Mack suggested that possibly the sons and daughters could form a sub-group within this Association and then they could also continue after all the Association members are no longer around. Mr. Foley said the IRS would accept that.

Mr. Marsalek stated he did a lot of research and that when this group was formed it was so that the Association would go on in perpetuity. This change would keep the Sixth Division going. If nothing is done, then the Association would have to disband. He believes that the subgroup would be complicated. Perhaps the recommendation could be accepted with the understanding that the Board would review the tax ramifications.

Frank Mack moved that the Board recommendation for full membership for the sons and daughters be approved, providing that the IRS provisions are reviewed and satisfied, seconded by Sal Mistratta. All in favor, except one opposed, motion carried.

Some discussion on the tax status was discussed. Mr. Marsalek suggested that it would not be a big deal if the tax exempt status was lost, because at this point the Association does not really need to be tax exempt. Mr. Petriello will discuss this with some lawyers. Mr. Pierce stated that at the Sons and Daughters meeting they felt like we were against them. He told them that it was felt that they might take over. They adamantly denied that was

what they wanted to do, they only wanted to help. Mr. Pierce further stated that this Association is finding it hard to find people to take positions, although some members still have the energy to do things. If the sons and daughters are brought in then the Association

will continue forever. Mr. Essex emphasized that they want to help us, not take over.

Mr. Marsalek stated for the record that the by-laws would be amended so lineal descendants would be qualified to be full members of the Association pursuant to the research on the tax status issue. A Special Board meeting will determine this issue and members will be notified through the newsletter.

Mr. Marsalek announced that he would hold another meeting per the bylaws immediately after this meeting for

organizational purposes. He asked everyone to stay.

Mr. Pierce mentioned that the Board authorized \$1000 to be donated to The Okinawa Museum for maintenance and upkeep.

Many groups in the city are honored to be able to sponsor an event for the reunion. The Biltmore Hotel will be used and the room rate is \$75.00 and totally handicap friendly. The dates are September 16 to 20, 2008. President Essex stated this site was accepted at the 2006 Reunion in Harrisburg, but needs to be approved again this year due to lack of minutes. George McAfee, seconded by Andy Horvath, moved to accept by acclamation the proposal for the 2008 Reunion in Oklahoma City. All in favor, motion carried.

Mr. Foley stated that the reunion organizer

President Martin Essex called the meeting to order at 10:00 a.m. and welcomed everyone.

Reverend Frank Mack gave the invocation.

President Essex appointed Andy Sinatra as Sgt. at Arms.

All officers were present except Editor Joe Singleton and Past President Harold "Pete" Howell, both excused.

Unit Directors were also in attendance, as well as Reunion Chair John Foley.

President Elect Marsalek led the Pledge of Allegiance.

Secretary Terpinas declared a quorum (50% of the membership present) was in attendance.

President Essex stated that the Meeting Notice was published in the spring and summer issues of the newsletter. He had a copy available. Mr. Terpinas and Reverend Mack moved to accept Proof of Meeting Notice. All in favor, motion carried.

President Essex stated that due to lack of minutes from the last meeting, electronic devices were being used today to record and Lisa Benedetti was present taking minutes. He asked that everyone state name and position when speaking.

Report of Officers:

President Martin Essex: No report.

President Elect Ed Marsalek: The Finance Committee met this morning to conduct an audit. The committee submits that the accounts appear to be in order and accurately state the financial status of the association (meeting minutes attached). According to the by laws, this was an internal audit. Mr. McConville, treasurer, was asked if he would like the discretion to hire an outside firm for an audit. He stated that it might be a good idea. A by-law change would be needed to Article 10, Subsection 9. Mr. Marsalek and Reverend Mack moved on behalf of Mr. McConville, this amendment to the by-laws: The Treasurer, unless otherwise ordered by the Board of Directors, may retain a firm of certified public accountants to perform a certified audit of the books and records of the Association. Reverend Mack asked if the Treasurer would now hire an accountant. Mr. White felt that the internal audit should be accepted. Mr. McConville had asked that this authority be given to the treasurer, so no aspersions would be made. Mr. Marsalek emphasized that no one had questioned Treasurer McConville's integrity. The audit was done according to the mandate of the bylaws, he said.

All in favor of the motion to recommend the by-law change to Article 10, Subsection 9, motion carried.

Secretary Tom Terpinas: He purchased a recorder, which will be an official recording device. It is available for anyone to use for meetings. He will keep it. The question of reimbursement for this cost was tabled until later on the agenda. There was a question of where the Seal of the Division was kept. He also has that seal.

Treasurer Joe McConville: He distributed a copy of the Financial Statement for September 2006 to September 2007, which will be published

in the newsletter. There are two accounts. The general account balance is \$33,046.81 and the overflow account is \$72,335.37 for a total of \$105.382.18.

Mr. Petriello, seconded by Mr. White, moved to accept the report of the Treasurer and commended Joe and his wife. All in favor, motion carried.

Chaplain Frank Mack: His duty is to bring comfort to families on their bereavement. He sends personal letters and tries to include any information he has on that member. This year the bell at the Memorial Service was rung for 131 Marines. Reverend Mack stated that he spends approximately \$250-300 per year, but that it is his donation to the Association. The past chaplain of many years, Claud Wilkins, recently passed away and the Memorial Service was dedicated to him.

Reverend Mack stated that he noticed the Regimental Flags were missing from the Memorial Service. Mr. Foley replied they were here at the hotel, but none of the Unit Directors picked them up. President Essex

commented that the reunion chair should be responsible for shipping to next site. The Unit Directors should be responsible for getting them to the Memorial Service. The decision of the next site would be decided at the general meeting.

Judge Advocate Sam Petriello: He reported that according to the by-laws, in order for an amendment to be made there must be 30% of the membership or 100 members present at the General Meeting. Mr. Foley stated there were approximately 150 members present. Mr. Petriello suggested that the number of members that need to be present at the Annual Meeting be reduced to 50 members, as so many members are passing away. All in favor, motion carried.

Membership Chairman Jim White: Flo Dornan is the Membership Manager, while he is the Membership Chairman. He reviewed the report prepared by Mrs. Dornan (attached). There are 2,486 members inclusive of the various categories (i.e. regular, associate)

Some people send Mrs. Dornan their dues and include money for scholarships. Mr. White has requested that when this happens, Mrs. Dornan should return the check to the sender and ask that it be split out and sent to the scholarship organization, the remainder sent to the association. The Judge Advocate approved this procedure.

Mr. White recommends that Mrs.

Dornan's contract be extended as she has done an excellent job. The proposed contract was presented.

Reverend Mack asked where memorial money should be sent. Mr. McConville stated it should be sent to Mrs. Dornan, and then it is deposited in the general fund.

Public Relations Bill Pierce: The job is to get recognition for the Sixth Division and keep the memory of it alive. The Ultimate Battle is due out this month. It pertains to Okinawa. Mr. Pierce gave the author names for contact and several members including Reverend Mack are mentioned. There is an article on it in the November WWII Magazine.

The Massaponik High School Football Team in Fredericksburg, Maryland, is wearing the Sixth Marine Division emblem on its helmets all season to honor the Division.

The Sugarloaf Hill painting is completed. It will be donated to the National Museum of the Pacific War in Texas. It will be framed and installed in November. Prints are available for purchase. A dedication will be held in the spring. Ward Lowing has said that he would pay for the frame, which could run between \$1000 and \$1200, but Mr. Pierce feels Mr. Lowing has done enough. Mr. Pierce mentioned that the original Final Flag painting is missing. He is trying to find it and it should be placed in the Okinawa Room at Quantico when found. A bronze plaque has been placed at the Tommy Oliver football stadium in Panama City, Florida. He was a member of the 29th Marines.

Mr. Pierce stated he tries to get veterans to speak to different groups when he gets requests, but is not having a lot of luck. The Final Battle/Final Flag print in the name of the Sixth Marine Division has been placed in the education room at the USS Yorktown. Memorial markers are

sent out to families for gravesites.

The Okinawa Museum is open. 60-70% of it is dedicated to the Sixth Marine Division. Approximately 1500 people visit it a month. The Association sent \$1000 to it last year and he would like to see more support for it. President Essex requested that the donation be made again. *Mr. Pierce, seconded by Mr. Terpinas, moved to donate \$1000 to the Okinawa Museum. All in favor, motion carried.*

Andy Sinatra, a past president, asked that the cost of the frame be approved also. *Mr. Pierce, seconded by Mr. Terpinas, moved to approve up to \$1500 for the purpose. All in favor, motion carried.*

Mr. Pierce stated that the Sixth Marine Division has an Internet site that has a lot of information and great links for families trying to trace members. Mr. Pierce is the web manager. There is a webmaster, Lucy Young, who makes approved changes.

Service Officer Carl Sproatt: Markers are mailed when he is notified. He sent approximately 50 out this year.

Andy Sinatra. asked if the memorial plaques the Sixth Marine Division donated to Quantico and the one in Hawaii are being taken care of. Mr. Foley said yes. At Quantico, a unit of young Marines has been assigned that task.

Past President Pete Howell: No report.

Reports of Committees:

Nominations: Mr. Petriello stated that the past three presidents form the nominating committee. Those who want to run for office should submit their names. Names can also be submitted from the floor at the general meeting.

Resolutions: No report. *Membership:* No report.

Bylaws: Mr. Petriello stated there was one proposed change on the number of members needed at the general meeting and one item under Old Business pertaining to the Sons and Daughters.

Scholarship: Mr. Petriello reported that 13 grandchildren were awarded approximately \$3800 each. \$59,105 was awarded in total this year. Since 2002 there have been 63 Awards in the amount of \$177,785. The Association has sent about \$23,000 to this organization.

Old Business:

President Essex stated that because of the lack of minutes from the last Board meeting, the member directory was not done. He showed the directory as compiled by Mrs. Dornan. It would be sent to all members after it has been updated as of January 1, 2008. It is in a 3 ring format and people can put it in their own binders. Mr. Singleton and Mr. Terpinas are on the committee. President Essex got a bid from

acceptance of the bid to print the directory at a cost of up to \$7500. Reverend Mack stated that he uses the directory all the time and it needs to be updated. The last directory was done in 2003 and there have been many changes since that time. Some discussion was held on asking people for donations for the directory. An insert could be sent with the directory to this effect. Also discussed was when updates would be done. President Essex stated Mrs. Dornan would make the changes annually. As e-mail addresses are not included, perhaps a separate list of these could be included with the directory.

All in favor of the motion to recommend, *motion carried*.

Mr. Petriello reported that 4-5 years ago a proposal was made to include the sons and daughters as full members. He is proposing that the bylaws be changed to allow them full membership, which would include voting and holding office. This would allow the Association to continue when the veterans are no longer able to fulfill the positions. He also mentioned that the gender language in the by-laws would change, since daughters would now be included. Mr. Marsalek said that the bylaws were meant to be updated as time went on and policy and direction changed. The only other option would be to disband. He went to the Raiders Reunion. Mr. Terpinas added that there is not much choice, disband or continue with help. They would work with the current officers to gain administrative experience and some already are doing so. Mr. Pierce feels it is a difficult situation, as some members feel they can still function well. It was said the charter only allows Sixth Marine Division military members. Mr. Marsalek disagreed and stated that the Association is governed by the bylaws. Mr. Petriello added that only 2.5% of non-military members are allowed for tax purposes, but the number of active sons and daughters according to his calculations, should not affect the non-profit status. He has the proposed changes, which were written by a lawyer, a parliamentarian and himself. Reverend Mack also had mixed feelings, but sees that the torch needs to be passed.

Mr. Pierce stated that he got the sense at the Sons and Daughters meeting last night that the sons and daughters have an enormous amount of pride in their fathers and this would be an honor to them to be allowed to do this. President Essex added that they need to be given something to do, or they are going to turn away.

Reverend Mack moved to recommend to the general membership that the bylaws be amended to grant full membership in the Sixth Marine Division Association to lineal descendants. All in favor, motion carried.

New Business:



W. Roger Jamieson

Jamieson Was On The Hill That Night in May...

W. Roger Jamieson, F-2-22, died on June 3, 2007 after a brave battle with metastatic prostate cancer. He was 85. Enlisting in the USMC in 1942, he retired from the Corps in 1952 having attained the rank of Captain.

Roger participated in the invasion of Guam, where he was the liaison officer to Maj. Gen. Lemuel Shepherd. He then landed on Okinawa April 1, 1945. After working in headquarters and seeing the truckloads of Marines come back K.I.A., our dad volunteered for front line duty. Little did he know what he had asked for.

Lt. Col. Woodhouse sent our father and 25 buck privates up Sugar Loaf Hill on May 14. Our dad followed Major Courtney up the hill and saw him fall later that night. The Marines held the hill until dawn when they were called off. Only 9 Marines survived that evening. Dad believed he lost all the men under his charge that night.

Dad recovered from his wounds and attempted to return to the front lines when he was hit by a sniper.

Our dad came home from the war and raised a family and spent most of his business career working in the aerospace defense industry. He is survived by his wife, Betty, four children, 11 grandchildren and 2 great-grandchildren. One grandchild, Roger, preceded him in death.

Dad had a chance in June,1995 to revisit Sugar Loaf Hill, this time under friendlier conditions. He found some closure to old war wounds. The only other Marine he has met since from that night of battle is Lt. Ed Peseley. If anyone else was there and survived, our family would love to hear from you.

Our father, once a Marine- always a Marine, was proud of his association with the 6th Marine Division. We were proud of him and will miss him every day.


