Yes, we wanted to personally check out our trolley system, the Oklahoma Spirit Trolleys, and also our newest addition to our Metro Transit System, the Oklahoma River Cruises. Both of these systems link together and, with a trolley stop RIGHT IN FRONT OF THE BILTMORE HOTEL, this will certainly be a fun and economical way to get around to many of our attractions without having to drive. At least, that's what we were told — BUT, we wanted to MAKE SURE before we recommended it to you.

Due to timing restrictions, we decided to take a trolley ride starting from our Bricktown area to the Biltmore Hotel. We got on the Orange Line (which runs every 45 minutes — 50 cents for seniors & disabled, \$1.00 basic fare) in front of our beautiful Bass Pro Shop in Bricktown. At the next stop, Regatta Park, by the Oklahoma River, all the other passengers got off the trolley, leaving Joan and I alone with the driver. 



## Twelve Sixth Division Marines Invade Texas Hill Country WWII Museum

Memorial Day, May 26, 2008, was a special day for 12 Texas members of the Sixth Marine Division Association. The morning began with a touching memorial service at the Admiral Nimitz Museum in Fredericksburg, TX in the Veterans Walk of Honor. At 1 PM, the painting of "The Battle of Sugar Loaf Hill" was dedicated by the division Marines who came from all over Texas, which can be a "far piece."

Charles Pearson, Allan Phillips, Billy McClellan, Anerson McBride, Daniel Freytag, Harold Walker, Ray Schlinder, M.E. Corbitt, D. C. Rigby, Floyd "Stoney" Hill, Oliver Welch and Jack Dornan were present.

Jack Dornan opened the dedication with a large map on the wall and a short history of the battles on Okinawa (also in a handout) and specifically of Sugar Loaf Hill. Ray Schlinder gave a very personal talk on his experience of the battles at Sugar Loaf as did Allan Phillips. They each gave their version of the battle in a slightly different manner. Personal emotions ran high and you could feel the bond between these men who shared this battle.

Not only did we have 12 Marines at the dedication, but many sons, daughters and friends, totaling 42. The dedication was a perfect time to renew old friendships and make new ones and a lot of that was going on.

Much credit must be given to Ward Lowing of the Halls of Montezuma Print Co., Sierra Vista, AZ, who came up with the idea for the painting together with Ray Schlinder. With the help of Bill Pierce, they gathered pictures, found an artist to paint the picture and located a museum to accept the painting. Ward himself funded the cost of the painting (many thousands of dollars) for the sole purpose of recognizing the men of the Sixth. He is a true friend of the Sixth Division.

A CD and DVD of "Before You Go," music and video aimed at memorializing the shrinking numbers of WWII and Korean veterans, was presented to the museum by Jack and Flo Dornan. There will also be a set given to the Sixth Marine Division Association and the U.S. Marine Raider Association with the hope it will be played many times at the respective reunions.

Anyone visiting the San Antonio or Austin area should make a trip to Fredericksburg and the National Museum of the Pacific War, home of the Admiral Nimitz Museum. "The Battle of Sugar Loaf Hill" painting will be temporarily housed in its present position but permanently moved to a new area of the museum, which will be ready in three years.

## Museum Is Legacy Of Chester Nimitz

The Museum of the Pacific War is located in Fredericksburg, Texas because that small city was the birthplace of Admiral Chester Nimitz, whose family ran a hotel there. The hotel building still exists. Its frontage is built in the form of a ship's prow. The museum began life as sort of a hometown affair but has grown in recent years to national recognition.

Nimitz was in Hawaii expecting to run what was a naval war throughout the Pacific Ocean. Douglas MacArthur had escaped to Australia from the Philippines and figured he should be in charge. They duked it out until an exasperated President Franklin Roosevelt split the ocean into two parts, one for each.

Nimitz got the Navy and Marine portions, mostly atolls and open water; MacArthur got the big Army battles and a hog's share of the glory. Nimitz received respect and gratitude — and a museum.

## "Painting is Nothing Short of Awesome"

Dear Joe: I just returned home from Fredericksburg, TX after dedicating our painting, "The Battle of Sugar Loaf Hill." I must say the painting is nothing short of awesome; it is spectacular. The artist got into great detail and color. It's beautiful to say the least.

It is temporarily hung in the Bush Room of the museum. They just broke ground for a new museum at least four times as large as the present one. The painting will be hung in a most advantageous location when completed.

The man responsible for the painting is Ward (Bif) Lowing, a friend of mine from Arizona. Bif has invested much time, effort, traveling and cost to this point. It took the better part of three years from the start to the end of this great project.

I believe we of the Sixth Marine Division should thank him with an open letter in the Striking Sixth to show our appreciation. It should include this thought above all others:

"Bif, you have done much to keep our Striking Sixth Division in the minds and hearts of all the people who see the painting. You've helped us make history once again by keeping our name and reputation alive forever. Thank you from the bottom of our hearts."


## Asked to Stand Forward, This Marine Responded

Not only did Chris Clemensen, E-2-29, agree to represent the Sixth Division at ceremonies honoring us at Golden, Colorado, he faced a situation that would normally terrify the stoutest of combat Marines. He was asked to make a speech at the ceremony — and on television.

Facing fellow Marines, families and a civic delegation featuring the mayor, Chris rose to the occasion. He began:

"Greetings, ladies and gentlemen. It is with great pride that I speak for the Sixth Marine Division. I also want to thank the Marine Corps Memorial Association for its tribute to the Division. We are here today to dedicate this memorial to the men of the Division, both living and dead."

Chris went on to recount the history of the unit, including the 10 days it took to take Sugar Loaf Hill, a battle in which Chris participated. He got almost rhapsodic describing the thinking behind the Division patch. (Probably,

it does have more actual content behind it, as Chris' talk made clear, than any other division patch except that of the First Division; something that probably hasn't occurred to most of us.)

All six division stones were financed by the Golden Civic Assn. Other organizations, such as the Marine Corps League were involved. Official sponsor was the U.S.M.C. Memorial Association.

According to Chris, who lives in Denver, there was one other attendee from the Division, a corpsman from Cheyenne, Wyoming, whose name he didn't catch.

## Ward Lowing Deserves Appreciation for Painting Effort

It was a family affair as Sixth Division Marines, friends, sons and daughters attended Memorial Day ceremonies in Texas to dedicate the Sugar Loaf Hill painting at the Museum of the Pacific War in Fredericksburg. Those present report that it was quite a show, but the story really began miles to the north in Alaska.

Ward met Ray Schlinder, K-3-22, on a fishing trip there and was intrigued by Ray's reminiscences of war with the Sixth Marine Division on Okinawa. Ward is not a veteran, but patriotism and love of our military races through his veins. He owns "Halls of Montezuma," a company that produces and sells fine historic and military prints.

Ward determined to honor our Sixth Division and contracted with a renowned artist, Pierre De Wispleare to paint a large panorama that would depict the Division in the struggle for Okinawa. Sugar Loaf Hill was the theme as it was felt by Ray and myself that this battle would represent the Division well, as no other singular action in the campaign was as bitterly fought as the valorous and courageous attack on that ferociously defended hill.

Though it is nigh impossible to truly create the battle scene of such a day-by-day effort by our Marines, it was decided that it should be attempted. The artist was supplied with many photos, drawings, equipment and such to be placed in the painting. 


He has also visited Ray's home and mine with his lovely wife Chrissy, spending many enjoyable days.

## Historian's Corner

More and more frequently the correspondence I receive is from children and grandchildren of veterans requesting information about their father or grandfather. They have watched a show on the history channel or read a book, hopefully mine, that has peaked their interest. Enough time has passed now that the "greatest generation" and their times are the topic of many books and documentaries.

The National Personnel Records Center (NPRC) reports over 4,000 requests for military personnel records daily. Unfortunately more often than not family members can no longer ask the questions that they have to their deceased relative and often don't even know where to begin to look for information.

First I hope that each of you will take the time to record your experiences for your descendants. Whether you privately document your story on a tape recorder, dictate to some grandchild who shows an interest or

write it yourself — make the time, it will be a valued family heirloom. Although your children may show no interest, (probably because you did not encourage their questions in the past, you modest bunch) someone will benefit in the future from your efforts. Secondly, make sure that in your papers your service number, when and where you served, branch and where you were discharged are available. Even if you leave sketchy evidence these few pieces of information will allow some familial super sleuth to research you in the future.

Now to the many sons and daughters who receive the newsletter or browse our website; there are ways to obtain your parents' military records. Veterans or next of kin of a deceased veteran may use vetrecs.archives.gov. All others must fill out the Standard SF180 form available online or contact the archive by fax 314-801-9195 or mail. Write to: The National personnel Records Center, 9700 Page Ave., St. Louis, Missouri 63132

Additionally, you may be able to obtain the form at your local Veterans Administration office. To complete the form you will need the complete name of the service member, a service number (birth date and place, especially if you don't have this) or social security number, branch of service, and if possible dates of service, place of discharge, last unit assignment, and place of entry into service. The processing time varies depending on how much information you are able to provide but currently they are averaging processing records in three weeks.<sup>2</sup>

Another website that can be helpful is: http://members.aol.com/forvets/htomr.htm Hopefully this information will make it somewhat easier to research your family's history. It should also be a reminder how important it is to share your historical legacy. No time like the present, yours is a rich story. — Laura Lacey




