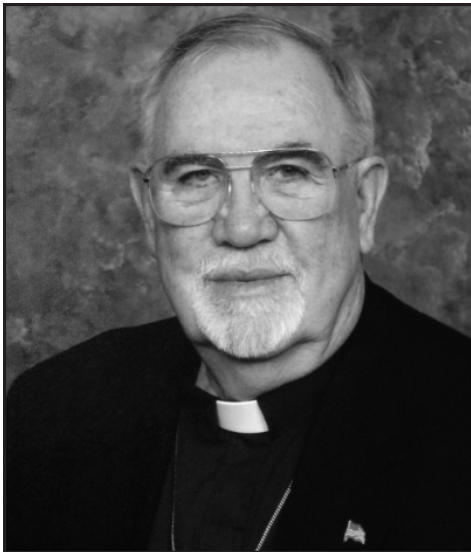

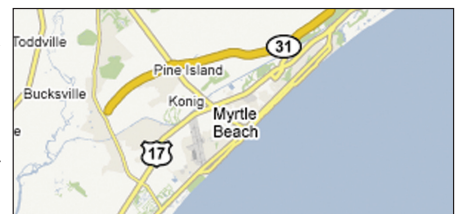
Under Strength (and old) Marines Will Advance to Myrtle Beach, SC

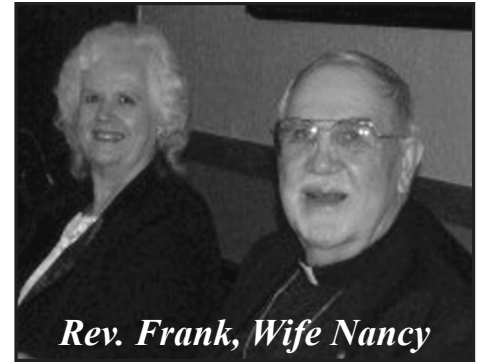
God be with you, Frank, until we meet again,

Sam Petriello's Daughter One of Top 20 Teachers

Nancy Petriello Barile has been named by the USA Today newspaper as one of the best 20 teachers in the nation. She teaches high school English in Revere, MA.

Nancy is the daughter of Sam Petriello, our own Judge Advocate and long-time member of the association.

USA names an All-USA Teacher team every year. The criteria are obviously very high. Each teacher is awarded \$2500 to share with the school.

Originally a paralegal, she began her teaching career at 35. She is 48. It had been a lifetime desire, she told her local newspaper.

"Nancy's a constant innovator," according to her department head. He added that the school has a large immigrant population with a majority on subsidized lunch programs. She keeps them interested in the subject matter, he said.

United States Marine Corps Birthday Message - 10 November 2008

1. During the summer of 1982, in the wake of a Presidential directive, Marines went ashore at Beirut, Lebanon. Fifteen months later, on 23 October 1983, extremists struck the first major blow against American forces - starting this long war on terrorism. On that Sunday morning, a suicide bomber drove an explosive-laden truck into the headquarters of battalion landing team 1/8, destroying the building and killing 241 Marines and Corpsmen.

2. Extremists have attacked our nation, at home and abroad, numerous times since that fateful day in Beirut. Their aim has always been the same - to kill as many innocent Americans as possible. The attacks of 11 September 2001 changed our nation forever, and our president has resolved that this nation will not stand idle while murderous terrorists plot their next strike. Marines will continue to take the fight to the enemy - hitting them on their own turf, crushing them when they show themselves, and finding them where they hide.

3. Only a few Americans choose the dangerous, but necessary, work of fighting our nation's enemies. When our chapter of history is written, it will be a saga of a selfless generation of marines who were willing to stand up and fight for our nation; to defend those who could not defend themselves; to thrive on the hardship and sacrifice expected of an elite warrior class; to march to the sound of the guns; and to ably shoulder the legacy of those marines who have gone before.

4. On our 233rd birthday, first remember those who have served and those "angels" who have fallen - our reputation was built on their sacrifices. Remember our families; they are the unsung heroes whose support and dedication allow us to answer our nation's call. Finally, to all Marines and sailors, know that I am proud of you and what you do. Your successes on the battlefield have only added to our illustrious history. General Victor H. "Brute" Krulak said it best when he wrote, "... The United States does not need a Marine Corps ... The United States wants a Marine Corps." Your actions, in Iraq and Afghanistan, and across the globe, are at the core of why America loves her Marines.

Another chapter in the Okinawa Memorial story has ended. Edward (Buzzy) Fox, G-2-22 and former president of this association, reports that Yoshio Yazaki has died. He was the Japanese partner in the building and dedication of the Garden of Remembrance on Okinawa.

"We were an odd couple," Buzzy said, "A Japanese naval officer and a pfc machine gunner, who became friends. Also, it was never really explained to me how he knew that I had initiated a plan for a memorial on the island we had fought over."

However he knew about it, he reached Buzzy through Gen. Shepherd, and the two worked together to bring the memorial to fruition. Yoshio visited Buzzy in New Jersey, who in turn visited his friend in Tokyo.

The letter informing of his death also mentioned that Yoshio had been suffering from Alzheimer's for some years. Buzzy relates that had he known, he would have flown to Tokyo if only to say "Good bye and thank you."

"Yoshio and I found a peace bond with each other whose only mission was to honor our dead," Buzzy said.

I asked Private Partz, the legendary Devil Dog, who showed up briefly this morning, for Christmas suggestions. There is a book he said which would be suitable for aged Marines who have forgotten they were in a war. "This is the best firsthand account of island warfare in the PTO: *WITH THE OLD BREED AT PELELIU AND OKINAWA* by the late E. B. Sledge. "Sledgehammer" wrote it as a former member of K-3-5, First Marine Division. He minces no words and spares no pain. Sledge wrote, "The reality of battle was mud and mire with the stench of death filling the air. But, the binds of friendship formed were never to be severed." Sixth Division Marines will find his 325-page book, difficult to put down."

"Hmmpf! He must have gotten that idea from *Military History Magazine*, which lists Sledge's book as one of the 10 best ever written about war. They rank it right up there with *War and Peace* and *The Iliad*. He could also have mentioned *Goodbye Darkness*, another book on the Okinawa Campaign, which almost made the cut. Not with Partz, however. Even though it was written by a wounded Sixth Division Marine who was there for most of it, the private and some others found it inadequate." — Major Cal Amity

The following is an excerpt from the book, *Gyrene*, subtitled *The World War II United States Marines*. Written by Wilbur D. Jones Jr., USNR (Ret), the following is found on Pages 39-40:

James A. McGuigan (Pfc, G/3/29). Born in Philadelphia, raised in Havertown, PA. Irish middle class. Motivation — to help my country. Enlisted USMC 1 November 1942 at the age of sixteen (16) years, sent to Parris Island, S.C. 1 February 1943. Some high school (Dropped out in Sr. year). Played baseball. No religion. 5'8.5", 140 pounds. Blond hair, blue eyes. Played the card game Hearts. Did not smoke or drink until service. Stayed single. Wrote home to family once a month and sent money home to mother. Drank beer with his buddies. No furloughs. Temptations were cursing and the opposite sex. Carried only toothbrush and shaver in his backpack. Was known as a hell raiser. Corps made him a hard worker. Received the Purple Heart and Presidential Unit Citation. Thing liked most: Winning. Liked least: Seeing friends get killed! Most memorable event: Okinawa's Sugar Loaf Hill, and all the men who were with him there. What got him through: Kept his head down and his eyes open. (Ed's Note: This information came from the Marine Corps League, Detachment 741, Newtown Square, PA., where James is listed as commandant.)

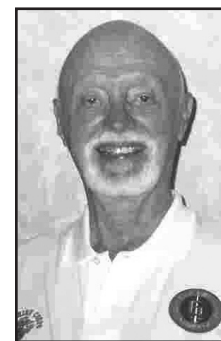
Suffice it to say we're still in the black. All of you are genuinely thanked for this.

Our own, Frank Mack, Division Chaplain, was elected President-Elect of the Association. He always does us proud. Congrats, Frank.

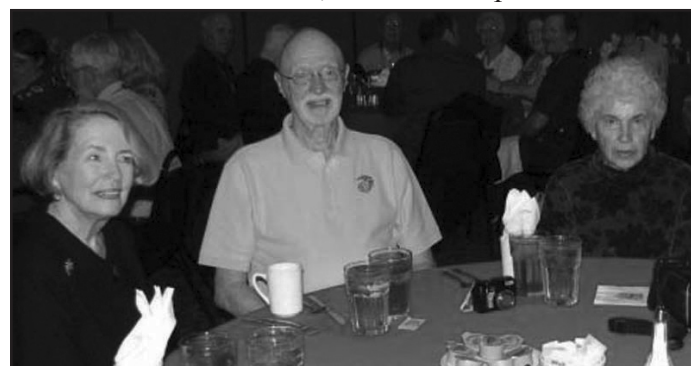

Annual Meeting of Members
(Abridged for Space)
September 20, 2008
Biltmore Hotel

38th Reunion**

President Ed Marsalek called the meeting to order at 11:00 a.m. and welcomed everyone. President Marsalek spoke about perpetuating and promoting the Association by having lineal descendants as full members, as the Raiders do. This would keep the 6th Marine Division legacy alive. It takes teamwork to get things done, which is how the Marines work and he asked everyone to do that, work together. For IRS purposes, the Association needs to be reclassified, in order to move forward with the lineal descendants idea. The Association is currently not in compliance because the number of veterans keeps dropping every year. Reclassification will not affect how the Association is run; it is only for legal purposes. The Board approved hiring a specialist to review the issue. Reverend Frank Mack gave the invocation. President Elect Sinatra led the Pledge of Allegiance. President Marsalek mentioned for the record that Lisa Benedetti was present to take the minutes and the meeting would be recorded.

Roll Call Secretary Tom Terpinas took the roll call: All were present except Treasurer Joe McConville and Public Relations Chairman Bill Pierce. Both had reported health difficulties and were excused. President Marsalek reported that Joe McConville is stepping down as treasurer due to ill health. Harold Walters has accepted the nomination to fill the position. He is currently the treasurer for the 22nd Marines. *Bill Twigger, seconded by George McAfee, moved to send a Certificate of Appreciation to Joe and Marion McConville. All in favor; motion carried.* President Marsalek commended the Reunion Committee. Secretary Terpinas declared a quorum was in attendance (50% of the membership present).

REPORT OF OFFICERS:

President Elect Andy Sinatra: Everything seems to be working fine. He asked everyone to let him know if there is anything. Members are also needed for this

position.

Treasurer Joe McConville: President Marsalek reported that Joe McConville sent a treasurer's report for the period of October 2007 to August 2008. An audit was conducted with the hiring of a CPA firm and it was clean. The balance was \$73,005.01. There were some major expenses this year, such as the Membership Directory.

Chaplain Frank Mack: The bell was rung for approximately 150 members. Everyone gets a personal letter from him, when he gets word of a death. He also receives many letters of appreciation. Rev. Mack stated he also sends out letters of encouragement and makes phone calls. He spoke about being with Carl Sproatt, who was a good friend, when he passed away. Rev. Mack brought back memorial markers and will continue to give them out until they are gone. Reverend Mack then stated that the 22nd Marine Association has been in existence for 16 years. Due to less and less attendance each year, they would like to have a joint reunion with the 6th Division, and then would like to merge. President Marsalek stated he likes the concept, but that how to do it would take some research. He invited the 22nd to attend the 6th Division reunion, as they were in the 6th Marine Division, and they could have a separate meeting during the reunion, as some of the other divisions currently do. Walt Kaminski commented that the Raiders had also proposed that awhile ago in order to have more leverage when booking a hotel. It had been thought that there could be a two week reunion with one group following the other or there could be two hospitality rooms with each group taking care of their own. Somehow, that never came about. President Marsalek asked everyone to think about this matter and perhaps it could be taken under consideration as old business next year. George McAfee stated that JASCO did the same thing. They dissolved their association, joined the 6th and hold a separate dinner during the reunion. You can only have one organization.

Editor Joe Singleton: The newsletter is in good shape and under budget. He needs more input from the membership to know what is wanted.

Membership Chairman Jim White: The membership manager report for 2008 was read. As of 8/8/08 the total membership total is 2,470 with the various classifications. The regular members total is 1,696. Also, \$10.00 is requested for a person to receive the newsletter. Currently there are 378 paid subscriptions for 2008 and 173 for 2009 so

far.

REPORTS OF COMMITTEES:

Membership: Jim White stated that Flo Dornan is doing a great job.

Bylaws: Sam Petriello stated that because of the passing of so many members it will be getting harder to get a quorum at meetings and for amendments per the bylaws. The current language calls for 100 members or 30% of regular and life members. He proposed the following amendments:

"Article VII Meetings (C) Quorum. The presence of not less than 30 or 10% regular and life members shall be necessary to constitute a quorum for the transaction of business . . ."

"Article XIX Amendments. . . These bylaws may also be amended by the unanimous vote of the active members present at the Annual Meeting of Members provided, however, that this method of amendment shall not be used unless at least 30 or 10% active members in good standing are present at such meeting."

George McAfee, seconded by Don Peterson, moved to approve the above amendments. All in favor, motion carried unanimously.

Scholarship: Mr. Petriello reported that 15 grandchildren were awarded \$20,550 for the current academic year. Since 2002 there have been 79 Awards in the amount of \$198,335 to grandchildren. A letter was also received from the President of the Marine Corps Scholarship Foundation stating that their policy as to the amount of money to be awarded to the grandchildren of the 6th Division was being changed due to the fact that there were more awards being given than money from the 6th Division. Mr. Petriello spoke with the woman who has been handling the scholarships, who assured him that consideration would still be given to the 6th Division grandchildren.

Nominations: Marty Essex reported nominations for all officers were prepared and he then conducted the elections. For each office, Mr. Essex stated who the Nominating Committee nominated, if the person accepted the nominations, and then he also asked for nominations from the floor three times.

President Elect – Reverend Frank Mack: Peter Drettos seconded by Watson Crumbie, move to close the nominations and elect Frank Mack. All in favor, motion carried.

Secretary – Tom Terpinas: George McAfee, seconded by Don Peterson, move to close the nominations and elect Tom

Terpinas. All in favor, motion carried.

Treasurer – Harold Walters: Sal Mistretta, seconded by Walt Kaminski, move to close the nominations and elect Harold Walters. All in favor, motion carried.

Chaplain – Reverend Frank Mack: Rev. Mack commented that when he becomes president, another chaplain will be needed. Don Peterson, seconded by Floyd Hill, moved to close the nominations and elect Reverend Frank Mack. All in favor, motion carried.

Editor – Joe Singleton: Jack Rice, seconded by Don Peterson, move to close the nominations and elect Joe Singleton. All in favor, motion carried.

Judge Advocate – Sam Petriello: Frank LaBarge, seconded by Reverend Mack, moved to close the nominations and elect Sam Petriello. All in favor, motion carried.

Membership – James White: Reverend Mack, seconded by Sam Petriello, moved to close the nominations and elect James White. All in favor, motion carried.

Public Relations – William Pierce: Jack Houston, seconded by Jack Rice, moved to close the nominations and elect William Pierce. All in favor, motion carried.

Service Officer – Vincent Mathews: Jack Rice, seconded by Dick Roberts, moved to close the nominations and elect Vince Mathews. All in favor, motion carried.

President Marsalek had each unit elect a director and had them sign a sheet. Directors for the units with no representation would be appointed.

Paulie De Meis

Dear Catherine, Rose, Adele, Cathy, Rose, Virginia, Roselle and Family, our Commandant, General Conway, LtGen Natonski, LtGen Helland, VADM Architzel, MGen Gardner, BGen Toolan, Col's Hartig, Padilla, Trafton and Holden and many, many others asked me to personally extend their sympathy to you on Paul's passing. In the Marine Corps we honor and remember our men and women for the difference they make for Corps and Country — and today we are here to honor and remember a friend, a brother, a father, a Godfather, a loving husband and one of our Corps' heroes, Corporal Paolo Stephen DeMeis, USMC (Ret.).

Corporal Paul DeMeis, the Brooklyn born son of Italian immigrants demonstrated his love of Country FIRST by enlisting in the Marine Corps in a time of war, SECOND by upholding the highest traditions of our Corps in combat, and FINALLY, by dedicating the remainder of his very FULL LIFE to brightening the lives of others and to inspiring the generations of Marines that have followed in his great footsteps.

A tough Italian kid who grew up on the streets during the Great Depression, Paul told me that he spent more time out of school than in, always looking for ways to earn money to help out his family. A Golden Gloves finalist in NYC as a young teenager, he grew up quickly and learned to handle himself in tough situations at an early age.

Paul was 12 when the Japanese attacked Pearl Harbor on 7 December 1941. He watched as seven De Meis brothers and cousins enlisted to fight. Paul became the 8th DeMeis to serve, enlisting in the Marine

Corps by way of a false birth certificate at age 15. As a note, the DeMeis Family collectively earned six Purple Hearts in WWII, with two family members making the ultimate sacrifice.

Paul turned 16 in Boot Camp in 1944. Then Paul spent 44 consecutive months overseas as the Corps caught up with his birth certificate shenanigans and started his contract over again at age 17.

That Paul survived the war is a blessing in itself. Indeed he saw close action against the enemy serving as a bazooka man on both Guam and Okinawa. Known to his buddies and most of us today as the "Bazooka Kid," he is mentioned in a number of books including "Killing Ground on Okinawa" by James Hallas. Paul was decorated for valor twice but, like most Marines, he'd never talk about that.

I know of a few of Paul's exploits — his famous Bazooka bank shot into an enemy cave, ducking out of his battalion aid station after being severely wounded to return to the fighting line and making a mulligan stew in the field to feed his whole platoon. Yes, folks, the DeMeis tradition of feeding everyone started way back then and continued without letup for seven wonderful decades.

When the atomic bombs ended the war, Paul's 4th Marine Regiment was sent to Yokosuka, Japan for occupation duty. He loved to describe the feelings he had when he and his buddies liberated Marine POWs from his very same regiment, the 4th, who had been captured on Corregidor Island in the Philippines and had been in the Bataan Death March. Paul and his buddies treated them to steaks and a parade from "their" Regiment. Paul loved to describe how proud he was to march in that parade.

After Yokosuka, Paul was ordered to China for what we would know today as peacekeeping duty. Unfortunately, trouble found the Bazooka Kid again in the form of Communist Chinese, who attacked an ammunition dump he was guarding, wounding him for a third time in three campaigns. This final wounding resulted in orders stateside and a permanent medical retirement as a Corporal of Marines.

Now Paul had great leadership as many of his officers and SNCOs in the 4th were Raiders. He also had tremendous mental and physical toughness — the kind that enabled him to overcome heart disease and other ailments for many years. The Bazooka Kid also had

a little luck and the Lord watching over him, but what really carried Paul through WWII and the rest of his life was a love story that started on the beach in Coney Island, NY when Paul met Catherine.

If you can imagine, Paul was dressed in an Italian Sailors' uniform that he'd acquired in trade from an Italian POW. Catherine, meanwhile, who was playing spin the bottle with her friends, thought he was an Italian from Italy, and was dared to go up to meet him. When she did, Paul got a bit fresh and planted an unauthorized kiss. Catherine, or "Guddie" as Paul affectionately called her, immediately gave the Golden Gloves champ a sock on the kisser that turned into quite a fat lip. It was love at first sight and punch! Catherine faithfully waited for her Marine to return home for nearly four years, while Paul kept her picture in his helmet and thought of her every day.

They spent the next wonderful 60 years together raising a family and I know that I speak for everyone here when I say how blessed we all are that Paul, Catherine and their family finally settled in Simi Valley, California.

Paul has been a fixture in the community supporting Veteran's events...He has given back...***he has given a great deal back.*** He has inspired thousands of young men and women at dozens of birthday ball and gatherings around the country and as far away as Iceland. He has spoken in classrooms across the county. He has cooked for wounded men returning from combat. He has brightened the lives of every one of us gathered here.

I reported to Ventura County in the summer of 1996 as a young, impressionable Captain and was introduced to a very special family of Marine Veterans — ***Giants of the Corps*** who performed incredible deeds that I grew up learning about — Men like Mike Torres, Russ Bond, Jimmy Emanuel, Knobby Walsh, Paul Mole' and Paul DeMeis, men I thought were indestructible, immortal. I suppose that no one, not even a Marine like Paul is indestructible, but he will always remain immortal as long as any of us are alive.

Paul never liked to say good-bye, so I will say ***so long*** Paul, God Bless and Semper Fi... we will miss you.

Paolo (Paulie) De Meis, the Fourth Marines' "Bazooka Kid," died October 24. He had been at death's door for three or four months with a heart condition, failing kidneys and liver. His wife Catherine, who is very proud of his attentions to the young Marines of the present, is ill herself but survives with three daughters.

"He loved the Marines," she said, and they loved him back. He cooked for the young men returning from combat on a regular basis, playing and joking with them. He attended many of their official and related functions, often as guest of honor. She said, "He was broken-hearted" when he could no longer visit with and be of help to his Marine buddies.
