# Jim Day Memorial Dedicated

On April 15th, 1999, a beautiful day full of sunshine, some 24 members of our Association attended a ceremony at the Medal of Honor Society in Mt. Pleasant, SC. The ceremony was held so that we could present to the Museum a statue depicting Cpl. Jim Day at Sugar Loaf Hill, Okinawa. A similar statue had been presented to Jim Day at the Portland, OR reunion last year. Since Jim's death we understand that the family has now placed the statue in the Sixth Division room at the San Diego Recruit Depot Museum.

Both statues were donated by Jim Chaisson G-2-22 upon his authorizing the work by the sculptor Lee Millett. It is interesting to note that this fine sculptor is the son of Col. Lewis Millett, he too a recipient of the Medal of Honor.


The statue was presented by Jim to Frank Currey, recipient of the Medal of Honor, Battle of the Bulge. Also accepting for the museum were Ms Sherry Russell, Museum Administrator, and Medal of Honor recipient Michael Novasell, Medal of Honor, Vietnam. The ceremony was conducted by Bill Pierce, Weapons Co. 29th. Speakers included President Tom McKinney and Tom Terpinas, President elect of our Division. Jim Chaisson and Bill Day, Jim Day's son who accompanied Jim and Nancy Chaisson on the trip from Atlanta, GA., also participated in the presentation ceremony.

# Death takes Simes, Scotia

Revered and respected by all the members of our association, Service Officer James B. Scotia was laid to rest with full Marine Corps honors on June 8 at the Veterans Cemetery in Bourne, Massachusetts. Active duty Marines in full dress blues provided the color guard, firing squad and bugler for this outstanding ceremony, which was attended by several of Jim's Sixth Marine Division Association members. Family members were profoundly impressed by the way Jim's comrades honored him at this final tribute to the gentle man.

In addition to his duties as Service Officer, Jim also represented his unit, the 6th Recon Company, on the board of directors of the association.

He put up a valiant struggle for his life after being stricken last year.

After his Marine Corps service, Jim was a motor vehicle operator for more than 28 years with the U.S. Postal Service. He belonged to the VFW, American Legion, Marine Corps League and the Masonic Lodge. His recreation was bowling.

Jim's wife, Jeannette, son Kirk, and daughter Cheryl survive him, along with three grandchildren, one brother and two sisters.

Harry Simes, Jr., a founding member of the Sixth Marine Division Association died of a heart attack on June 18, and was buried with full Marine Corps honors at King of Prussia cemetery in Pennsylvania.

Harry enlisted in the Marine Corps while a senior at Radnor High School in Fort Wayne, Pennsylvania and reported for recruit training to Parris Island after graduation. After that, he was sent to Camp Pendleton, California, then shipped overseas to join Company F, 2nd Battalion, 29th Marines as a BAR man. After the battle of Okinawa, he returned with his unit to Guam and then to Tsingtao, China.

When the Sixth Division was deactivated he was reassigned to the 1st Marine Division until he was discharged in November, 1946.

The true meaning of Gung Ho.....Work together....Get it done. The team effort prevails.

Notes, cards, letters, and phone calls continue to find their way to this desk and all are an ode to a good reunion, and emphasizing the informality and time able to be devoted to old friends and doing what they wished. The content of such communications have been most rewarding, making the entire effort well worth it. Many have been passed on to the Editor and may appear elsewhere in this issue or one that follows.

This Membership Chairman, for the

first time in almost five years in office, failed to make a formal report to the officers and members in attendance at the Arlington gathering. The reasons were twofold; first, seeing to the many details in planning for the Mini was very demanding with regard to time. One must be involved in such an undertaking to fully realize what is involved. # 1999 Reunion Report

Due to the sustained efforts of our treasurer, Bradley Safreed, the Sixth Marine Div. Association now has a U.S.. Federal tax exempt organization status under section 501-c.

This status will now enable the reunion at Buffalo to apply for a tax exempt status in New York. This has been applied for. There are specific requirements that have to be followed when we get this status.

The reunion cannot be completely successful until the banquet is fully booked in advance and paid for. The price is rightMost of the members who have made reservations with the Adams Mark Hotel, guaranteed with their Visa or some other credit or debit card and will have to do noth-

ing until they arrive at the hotel. On that day they will give to the committee, which will be in place near the check-in desk, a check for their full stay at the required price of \$70.00, plus 13% occupancy tax, for each and every night they intend to stay at the hotel.

All members who have guaranteed their stay at the hotel with a check for one night, plus the 13% occupancy tax, will receive their check back from the hotel. When they arrive for their stay, they will give to the committee present a check for the full amount needed for their stay: \$70.00 plus 13% occupancy tax for each night that they will stay at the hotel.

All members of the Sixth Div. Assn. should understand that the original price

for the hotel in the signed contract, made prior to this committee and myself getting involved at the Kentucky reunion, was \$80.00 per night plus 13% occupancy tax. We the committee, have turned the \$10 saved back to the membership attending the reunion rather than using that money for reunion expenses.

We must now find alternative ways to make expense money to keep the reunion solvent. There are no hidden or added charges on any of the listed events with the tour operator, hotel, etc. We have added a small extra fee on the very reasonable banquet charge. Don't forget the one hour free cocktail party with food on Monday, Sept 6th and the free gala cocktail hour on Friday, September 10th. # Another Side of the "RATS"

The Tunnel Rats have become rather well known for our caving adventures (more of those to come in another article) however, there is a much more serious side to what we do. Usually when we are fulfilling one of our more serious obligations, we are known as the Battle of Okinawa Historical Society. At this time of year when the Battle of Sugar Loaf occurred and the Battle on Okinawa ended I am reminded of the events that occur today on Okinawa to commemorate them. One of the greatest honors that I ever had was getting to partake in both the ceremony to honor Sugar Loaf and the ceremony at the Peace Park on Okinawa to honor our dead in June that the Battle of Okinawa Historical Society does.

For those of you who have never been to Okinawa, the Peace Park is located on the southern end of the island where the 32nd Japanese Army had their headquarters. The spot now is extremely lovely with the beautiful blue water below and the jagged cliffs and lush foliage all around. The highest point of the park is the spot where Ushijima and Cho committed sep-

Monuments from each prefecture in Japan mark the way to this high spot. These monuments honor the casualties of each individual prefecture. At the foot of this area is a valley and this is where the main section of the park lies. In the center is an eternal flame in a pool of water. Looking into the pool one sees a map of the world with Okinawa sitting where the flame is.

Then facing away from this pool one sees wall after black wall. Unlike the Vietnam Memorial in DC., the walls are panels and are not straight. This broken look is to give the impression of waves; "Waves of Peace radiating out from Okinawa." On these black walls are the names of the Okinawan, Japanese and "other foreigners" who died on Okinawa. Here one really understands the full impact of the Battle of Okinawa, the walls seem to go on forever!

Each year on Okinawa, on June 23rd, there is a tremendous peace celebration put on by the Okinawans and the Japanese to commemorate the end of the Battle of Okinawa. Some Americans believe that not

enough has been done to honor our part in this battle or to pay proper respect to our American servicemen who lost their lives in that Battle on this day. The Battle of Okinawa Historical Society decided that it was important to make sure that our servicemen were properly honored too, during this important anniversary. We developed a program to make sure we were part of the festivities. It has now become an annual event. We were helped by the Masons and the Post Exchange who provided us with small American flags.

The Marine Band on Okinawa had two young men volunteers to play echo taps and several news organizations came out to film us. Prayers were said, the poem by Gannon, The Helmet on a Rifle was read and then we placed flags at each panel of the wall where the Americans names were. Something happened that touched me more than I can ever express, as Americans made their way forward to take a flag to place at a panel so did Okinawans and with great care they invited themselves to our little ceremony and helped us honor our

Then taps was played. The two Marines picked different spots in the park and began. People all over stopped and watched and listened and the sound carried out.... Across that little island, across that blue water and into my heart. Peace, what a wonderful gift those men have given me. Peace, what a wonderful gift each of you gave this world.

# Air Force Memorial

This is the latest information on the public hearing concerning public comment on the environmental assessment for the proposed Air Force Memorial site on Arlington Ridge. Larsen, the Chairman of the Air Force Association; retired Gen. Shaud, the Executive Director of the Air Force Association; and former ASAF (M&RA) Rodnev Coleman. Their theme was all the same—that they were incredulous that the Marines were upset with the process. They also tried to instill justification for an Air Force Memorial because the Army Air Corps lost more men in WWII than the Marine Corps. They all stated that the AFMF had always complied with all the regulations and "dotted all the I's and crossed all the T's." What they completely ignore is that "even if what they say were completely true," they still have to go through the prescribed process and the site can be disapproved anywhere along the line.

Assessment of last nights hearing is that the Air Force got in some good licks primarily because of the horsepower they brought in to speak. However the comments from the Marine family, Marine supporters, area residents, runners and citizens concerned about the impact on the local environment were overwhelming and carried the day. Our emotional theme was throughout the comments and convincing as ever. However, the fact that it is not just Marines that are against the proposed site on Arlington Ridge is compelling. Given the comments from both

How do I get to the Adam's Mark Hotel if I'm...


... coming from the Rochester, Syracuse and Albany areas: travel Route 90-West. Take it all the way to Exit 53 (the overhead sign will read: "Downtown Buffalo"). Once you pass through the South Ogden Street toll barrier at the base of the exit, you will be traveling on Route 190-North. Travel approximately four miles to the Elm Street Exit. Exit leads to one way traffic on Elm Street. Follow Elm to North Division, turn left follow straight ahead seven blocks the hotel will be on your left.

... coming from the Erie and Cleveland areas: travel Route 90-East. Take it all the way to Exit 53 (the overhead sign will read: "Downtown Buffalo"). Once you pass through the South Ogden Street toll barrier at the base of the exit, you will be traveling on Route 190-North. Travel approximately four miles to the Elm Street Exit. Exit leads to one way traffic on Elm Street. Follow Elm to North Division, turn left follow straight ahead seven blocks the hotel will be on your left.

... coming from the Peace Bridge, Canada, and northern areas: Once you pass through the Peace Bridge toll barrier; OR from the Robert Moses Parkway; travel Route 190-South. Exit at the Niagara Street Exit. At the base of the exit, turn right. Travel up Niagara approximately one mile. At the intersection of South Elmwood and Niagara Street (at City Hall), turn right. Travel South Elmwood approximately 1/4 mile to the entrance of the Adam's Mark Hotel.

... coming from the Greater Buffalo International Airport: leaving the terminal and continue straight ahead onto the Route 33 West on-ramp. Stay on 33 West all the way to the end where it will blend into Oak Street approximately 9 miles. Follow Oak Street one half of a mile and turn right onto North Division. (Greyhound Bus Station on the corner). Follow North Division one half of a mile to the entrance of the Adam's Mark Hotel.

# VA Programs for Older Veterans

The number of Americans age 65 and older is expected to increase from 31 million in 1990 to nearly 59 million in 2025 as the baby boom generation of the 1940s and 1950s ages. VA, however, has been faced with the graying of the veteran population for some time. Currently, the median age of World War II veterans is estimated at 73.8 years. Today, nearly 9 million veterans are age 65 and older — 34.8 percent of the overall veteran population. By 2000, the number of veterans age 65 and older will peak at 9.3 million and represent 38.2 percent of the total veteran population.

On an average, the elderly have more chronic medical problems than younger persons. Their need for health-care services, especially long-term care, is much greater, creating a challenge to VA's healthcare system. That challenge is being met through a variety of programs directed toward the special, complex needs of the aging veteran population.





Thank you for sharing with us your daughter Juli's excellent review of "Saving Private Ryan." The clarity of her writing and uncomplicated analysis of the film's message made it a joy to read. For me, as I suspect was the case with many veterans, the film awakened long suppressed memories of mortal combat. But its message came through loud and clear to me as it did to Juli. I left the theater shaken but enriched by a new appreciation of the depth of commitment that dire circumstances can evoke in ordinary men.

Yesterday (Veterans' Day) my daughter, Yoko, called and touched my heart with a message similar to the one expressed to you by Juli. It brought tears to my eyes and later caused me to reread Juli's article with even greater appreciation. In her tribute to her Dad she wrote, "He never expressed to me anything but compassion for the enemy." That is a feeling I too brought home from "our war" and tried to transmit to Yoko and her brother. Both were born in wartime Japan. As infants, they barely survived the fire bombing of Tokyo and two other cities to which their mother (Later to become my wife) had fled. Juli's article also revealed your thoughts on how the weapons used against us by the Japanese compared with those the Germans used in Europe. After seeing "Ryan" I can only add, thank God the Japanese didn't have 88s and Leopard tanks.

Naturally we complied and took Gen. Geiger to Red Beach.

"As luck would have it, we also took him in on the third day to one of the Blue Beaches.

"There was an interview, with pictures on the first day, but I never saw any of them. Later we lost our tractor in the Sugar Loaf area bur obtained another one and made the Oroku Peninsula landing on June 4th."

# Thoughts while shavin'



FOUR CORNERS – the only place in America where 4 states all

where 4 states all come together. There's big circular dial there and when you sit right in the

center of it, where the lines intersect, your butt is sitting in four states — Colorado, Arizona, New Mexico and Utah.

There is really not much there, although it is a National Monument — just 20 or 30 small booths run by Navajos displaying various Indian-made items such as jewelry, belts, pottery and other souvenirs. Soft drinks are dispensed in separate cubicles, along with Navajo Tacos, — a delicious favorite here in the southwest.

Four Corners is off highway 190, between Shiprock, New Mexico and Tuba City, Arizona. It is part of the Navajo Nation. About 54 miles north of Tuba City is Kayenta, not really very much of a town. But it has a Burger King and that is a major part of this story.

Tourists stopping for a whopper and a coke will be made aware of a special exhibit and collection of souvenirs by the original owner of the Burger King, who was a Navajo code talker in the Marines in WWII. Looking at the exhibit more closely, I spied my first pleasant surprise — a big 6th Marine Division logo prominently displayed. Sure 'nuff.

Other military items were perused and a history of the Navajo Code Talkers of WWII in printed form was available to the public. But at the far end of the exhibit where diners could plainly see it was the jackpot — the best surprise of all — a personal bio of the Navajo himself, a member of the 22nd Marines, my own outfit. Hey, I might have known that Marine.

Then I saw the picture. Two Marines, a Corpsman, a Navajo, an Okinawan woman with two children. Easily identified were the two jugheads. They were a pair of my scouts — Elliott MacDonald and Julius Morris, and the young Corpsman whom I recognized but couldn't remember his name. And then to the Navajo. He looked like King Mike, whom we called "Chief." The caption under the photo proved me

correct. He was "Chief," the Navajo assigned to the scouts, in H and S Company, 22nd Marines. What a great find!

I spoke to a young lady named Kris who seemed interested in my excitement at the display. She called "Chief" Uncle Mike and told us he had died a few years ago at age 75. She mentioned his son Richard, now owns the Burger King and is building a new motel next door. She knew the family well. We went on our way but a month later we stopped in again and I got the phone number of Richard, called him later

and had a nice conversation. He was very pleased that I had taken the trouble to call him and was anxious to know more about his dad.

Ruins of past cliff dwellers, 1500 years ago, the Grand Canyon, ghost towns and magnificent red mountains appear in the great southwest. But the most poignant memory I have is finding the birthplace and one time home of our little buddy, King Mike, and knowing that he was an important man in his little corner of the world.

### About the Navajo Code Talkers

With the advent of World War II, many young Navajo men appeared at the first selective service registration armed with rifles, bedrolls, and food; they were ready to fight. By 1943, 1,400 Navajos joined the Army, Navy, and Marines; one-fourth of all these new recruits had joined as volunteers. Thousand of other hopefuls were rejected for the inability to speak or read English, and others for physical defects or being under-age.

Philip Johnston, a minister's son was often given credit for conceiving the concept of a Navajo Code. Although he was a catalyst in the concept of a Navajo Code, he was also considered a braggart and was suspect by the Marine Corps for disclosing the Navajo Code secret to the Arizona Highways Magazine in June 1943 through a report by the head of the Navajo Bureau of Indian Affairs, James Stewart:

The U.S. Marine Corps has organized a special Navajo signal unit for combat communication service. A platoon of thirty Navajos was recruited in the spring of 1942. Its members were trained in signal work using the Navajo language as a code, adapting a scheme tried with considerable success during World War I, when the enemy was completely baffled by the employment of an Indian language in front line communications. The thirty Navajo Marines performed their duties so successfully that the plan was expanded, a recruiting detail was sent back to the Navajo reservation in the early autumn and by early December, 67 new boys were enlisted.

The actual creators of the Navajo Code Project were Major General Clayton B. Vogel, Amphibious Force, Pacific Fleet, and Commandant Thomas Holcomb, USMC. Beginning with the battle for Guadalcanal, the Navajos proved to be excellent soldiers "island hopping" many Pacific Islands on their way to Japan. The Navajo Code Talkers fought in some of the fiercest battles of the Pacific war at: Bougainville, New Britain, Kwajalein, Saipan, Guam, Peleliu, Iwo Jima, Okinawa, and many smaller islands and atolls in between.

Transmission of the standard USMC code might read:

"XB6T7YJL9P2MDX4ZHP6GWQ8U4RINL2T9VD5A8SWK6FB4YQLBR8DCZ8RFP6QLK9D"

Meaning: "Jump off at 0600; move 50 yards left flank of C Company; proceed 200 yards; and report your position." The problems of the USMC code was that it could take up to four hours to decode; pieces of the message were sometimes missing; and only after decoding, it was relayed to the commanders. When you need an artillery strike, you want it to start now! The efficiency of the Navajo Code was that all of it was memorized and verbal. The Navajo Code Talker wrote down the messages as he received them. Many lives were saved because the code was quick, perfectly decoded, transmitted over telephone lines, and secure. Even after the war, all secrets about the Atom bomb were sent to San Francisco by Navajo Code. The secret of the Navajo Code Talkers was finally revealed on June 25, 1969 at a Chicago 22" reunion of the 4" Marine Division Association.

Moved, seconded and approved to accept the minutes of the General Membership meeting of Sept. 18,1998 as printed in the Oct. issue of our Striking Sixth Newsletter.

Pete Howell reported on the Quantico Memorial project. He reminded us that at the General Membership meeting last Sept. it was agreed to discontinue the BABA Program and transfer the remaining \$2,100 to the Quantico Memorial Fund. At the same meeting, approval was given for the Association to make up the difference, up to \$5,000 if the total funds by Nov. 10, 1998 had not reached the goal of \$65,000 to build the Memorial. The total funds raised to date is \$59,495 approx. This morning the Board of Directors agreed to issue a check for \$5,000 to the Quantico Memorial Project. All members are still encouraged to contribute to this project. Construction should start June or July and will be unveiled and dedicated during the April, 2000 reunion in Washington, D.C.

President McKinney, in the absence of Chairman Keith Tingley, reported on the very successful Punch Bowl Cemetery project, Feb, 4th to 28th in Honolulu. Forty-nine members made the trip from the mainland and were joined by six members who live in Hawaii. The

Marine Corps was extremely helpful. They arranged to haul the 2,000 pound stone from Rickover Air Base in Columbus, Ohio free of charge. The ceremony was well done and all members or tile Association can be proud of the stone placed there. Only \$2,000 was spent of the \$3,000 allotted by the association.

President McKinney also reported on theceremony last February aboard the USS Yorktown, which is the headquarters of the Medal of Honor Society. At the reception to honor the inclusion of General James Day as a Medal of Honor recipient for the occasion, a statue, similar to the one unveiled in Portland was donated by Jim Chaisson. A round of applause was accorded to Jim for his thoughtful generosity.

The president also reported that the 6th Marine Division Association had been reinstated as a tax exempt organization thanks to the work of Judge Advocate Mel Hecht, who was also given a round of applause.

Andy Sinatra suggested we contact the 1st, 2nd, 3rd and 5th Division Associations and encourage them to also be represented at the Punch Bowl Cemetery with a stone as the 4th and 6th have done.

D.C. Rigby, Directory Committee chairman, reported that the new directory will have larger print, telephone numbers, and a cross reference by state. The cost will be about 1 1/2 times the 1996 directory. Requests for bids will go out next week. Members should contact Jack Dornan with any changes or additions to their individual listings.

President McKinney discussed the possibility that he might run again for the office against anyone else who might seek the office.

### Reports

Tom Terpinas reported on the Scholarship Find Raising Committee and expressed appreciation to Ray and Joyce Robinson and Jack Dornan, who arranged for the printing of 2900 raffle tickets, letter of explanation and an invitation to participate as well as the return envelopes. He thanked the many members and their wives who stuffed and sealed the envelopes for mailing by bulk mail. Date of mailing will be about May 12.

Treasurer Safreed was unable to be present because of the graduation of his granddaughter from college. His report will be found elsewhere in this newsletter. The board voted to accept this report, which will also be presented to the general membership at their meeting this week.

DeWitt Joralemon, Projects in Memory of the Deceased Comrades Chairman, was not able to be at this meeting so his report was given by Past President Pete Howell. This committee has received the remaining \$2100 that was in the BABA fund at the request of the fund's chairman, Ken Gray and the approval of the meeting of the general membership on Sept. 18, 1998.

At that meeting approval also given for the Association to contribute up to \$5000 to meet the cost of constructing the Quantico Memorial. The total now stands at \$59,594.89.

In discussing the project, President McKinney said he had received many critical and threatening letters regarding the memorial, since he had begun working on it when he was first elected. Others reported receiving copies of the same material. Accusations were investigated and proven to be false.

Mel Hecht reported that he. President McKinney, and Pete Howell had met and reviewed the bank statement, a detailed accounting of all funds received and disbursed and other information involving the project. He even discussed the matter with a tax expert, who advised that as long as money contributed is spent for the Quantico Memorial and properly documented, there would be no problem with the IRS, even thought the funds have been in a separate bank account. Mel agreed with Director Andy Sinatra that in the future, all similar requests from a committee to raise funds for a project should be made first to the board of directors, then approved by the membership. He also agreed that all disbursements should be made by the Treasurer and all funding go through the treasurer's office.

In that regard, Pete Howell stated that Chairman Joralemon will be advised to get a written statement from the architect that (1) his services will be pro bono, that is without cost to the association; and (2) that the cap on the cost of the project will be \$65,000. Any money received over that amount would be retained for other memorial projects, with the permission of the donor. It was than moved, seconded and approved that the Treasurer be authorized to send an check to the Quantico Memorial Fund for \$5000.

As an aside, Mel reported that IRS authorities have reinstated the association's tax-exempt status, after a lot of paper and filing of forms.

Watson Crumbie reported for Membership Chairman Jack Dornan that Jack has set up his computer to differentiate monies received for dues, contributions and other donations into separate categories. His report on membership will be mailed to the board in about ten days. He reported that we have more new members than deceased notices; also more conversions to Life membership since the fee was reduced from \$100 to \$50.

D.C. Rigby, Directory Committee Chairman, said the new directory will be done in a larger type, with a cross reference listing by states. It will cost about one and a half time as much as the 1996 directory and will be mailed to all members who will be asked to contribute to its total cost. Telephone numbers will be optional.

#### Other Business

President McKinney noted he had received requests to have the reunions nearer to the center area of the country, which might be closer for most members. He also received requests



evenings, it's hard to imagine that the Park Service could issue a finding of No Significant Impact. We'll see!

Those that have been planning our strategy, Gen. Cooper and General Bice have been right on the mark. Our thanks goes out not only to all those that spoke so eloquently and convincingly, but also to those that wrote literally hundreds of letters and also those attended to show support for the Marine Corps cause. The period for public comment closed 22 March. The Park Service then has 2-3 months to forward their report and recommendation to the National Capital Planning Commission. We will keep you posted on the status.

# USMC Museum in the Works

CB Quantico has been established formally as the future site for what could ultimately be a 460,000 square-foot Marine Corps Heritage Center. It will include a national museum for the Marine Corps, a welcome center, a conference center with a hotel, and an IMAX theater.

Marine officials hope the center will become a regional attraction which will draw as many as 500,000 visitors a year. The exact site for the facility has not yet been determined.

According to current plans, the center will be completed in phases. The first will include a large part of the museum and the welcome center. That is expected to cost \$20-25 million. It could be completed as soon as 2004. The next two phases could take 10-20 years to complete.
