Memorial stone has tough time getting to Hawaii

Past President Paul Ulrich made many attempts to obtain attempts to obtain passage on airlines for free transportation of the memorial stone to Honolulu. Even connections in Washington kept giving him thumbs down. In the meantime the stone quarry where the stone was being made was set to close down for the winter.

Paul and Chairman Keith Tingley finally agreed to send the stone to Columbus, Ohio, where Keith's son, a retired Lieutenant Colonel in the National Guard had connections. The quarry people had found a memorial dealer there who would take the stone and transport it to an airport when arrangements could be made.

Keith started contacting those he'd come to know in Honolulu for help. Commander Griff Warren began calling firms that supplied products to the Navy in Honolulu, and Col. G. E. Castagnetti, director of the cemetery, began informing others of the situation. At this juncture the colonel stated to Keith that the National Guard brought things over to the Islands all the time. Keith then contacted his son and asked him to do some checking on behalf of the association. The C.O. of the National Guard unit in Columbus was a friend of his, as they had flown together in Desert Storm. The Commanding Officer found that a Guard plane was due to fly in on Feb.5, but the Defense Department said they could not haul the stone in one of their aircraft.

When Keith notified Col. Castagnetti of this, the colonel wanted to know who was holding up the process and was advised that a Col. Reynes at the Defense Department was the one to convince.

During their five-day tour, veterans from the 6th Marine Div. Association and their families visited Kaneohe Bay, then attended a long awaited ceremony at Punchbowl National Cemetery of the Pacific to dedicate the 6th Marine Div. Memorial last week.


Their visit to K-Bay Thursday began with a static display of the Marine Corps' modern weapon systems and vehicles in the morning. They walked through the static displays and were informed by their younger Marines of how the Corps had advanced since their days of service in WWII.

"I look to these younger Marines as my Marines," said James Bucklin, retired machine gunner, after hopping into an





Through another point of view, many younger Marines also enjoyed being visited by their "senior Marines."

"This is fun," said Pfc. Christopher Humphries, gunner for Weapons Company. "It's great to meet other Marines, more

experienced Marines, that have already been there, out on the firing lines of war."

"It's a good history lesson," said Lance Cpl. Kenneth Gallegos, displaying an M294 grenade launcher to his senior Marines. "It's motivating for us to have them come out here and show us so much respect for being their fellow Marines."

"My tour has been very nice," said Irma Bailey, wife of a retired Marine, as she sat nearby in the shade and watched her husband indulge in the displays of K-Bay Marines.

"Our tour here is very special for my husband, to talk with his fellow Marines from the division and remember his experience in the Marine Corps," said Bailey. "He'd join again if he could."

And as midday approached, the tour continued to Anderson Hall for some Marine "chow" followed by another informative session at the base theater. There, these leathernecks learned a little more about their Marines in Hawaii, including the modem Marine lifestyle, during a question and answer session.

Friday the 6th Marine Div. Association leathernecks recognized their fallen Marines with a ceremony at the top of Punchbowl Cemetery, overlooking the surrounding greenery-flushed mountain landscape.

"We're finally doing what we should have done a long time ago," said Thomas E McKinney, retired 1st sergeant, and president of the 6th Marine Div. Association, "recognize our fallen buddies."

"We're honoring the men that made us strong," said McKinney's wife, Dorothy.

Everyone who attended the ceremony followed the color guard to the 6th Marine Div. Memorial, where a rainbow of colored, flowered wreaths were standing by.

Each battalion had a representative place a wreath by the memorial, to signify the joint effort taken to make the memorial possible.

"No one man has made this possible," 1st Sergeant McKinney said, "all of us took part to make it possible. It was an all-hands effort."

And after the dedication was presented. "A" Battery, 1st Battalion 12th Marine Regiment leathernecks conducted a 21-gun salute with 75mm Pack Howitzers.

"It brought back many memories of the guys we were in tile battlefields with," said former Pfc. Warren Wanamaker, retired machine-gunner.

"The ceremony was outstanding," said retired 75-year-old 1st Sgt. Frank Magdich in his dress blues. "The memorial-was long overdue and well deserved!" he added after

Col. Castagnetti faxed a letter to the Department, stating that the stone had been given from the 6th Marine Division Association to the Punchbowl, so that in essence it was now the property of the government. Secondly, that the date for the dedication was set for Feb. 26, where Lt. Gen. C.W. Fulford Jr., Commanding General, Marine Forces, Pacific, would be giving the keynote address; and third, that an aircraft at Rickenbacker Airfield in Columbus, Ohio was already scheduled to fly to Honolulu on Feb. 6. In other words, this was an item that now belonged to the government, not the 6th Marine Division.

Two days later the Commandant's office called Keith for a copy of the program for the day and wanted it immediately. Within in an hour and a half, Keith had put together the schedule for the entire ceremony and faxed it to the office of the Commandant. Later an officer from the Commandant's office called to say that two men from the Defense Department were just signing papers authorizing the shipment.

Keith flew to Columbus to witness the loading of the stone on Feb. 4th — his 75th birthday. Unbelievably, the stone was the only cargo being shipped that day. The plane was going to Hawaii to bring back 50 military police that had gone over earlier to relieve the regulars who had been sent to Korea for training.

placing a small American flag by the memorial.

"This flag was placed at our memorial in Okinawa, I placed it here today, and it will eventually retire at the museum at Marine Corps Recruit Depot, San Diego, for the 6th Marine Division," said Magdich with a proud, wide grin.

The same sentiment seemed to ring for all the Marines from the 6 Marine Division.

"I was happy to have served as a

Marine," said Bucklin. "If I had it to do over again, I would."

The 6th Marine Division was the only Marine Division formed on the battlefield it was formed during the Battle of Guadalcanal in August 1944. The division was disbanded in April 1946.

About 22,000 Marines served with the 6th Marine Div., and more than 500 were buried at Punchbowl National Cemetery of the Pacific.

The painting will be honored by placement at the Heritage Foundation Museum and National Preservation Headquarters.

This will be located on the 55 acres of land for the housing of present U.S. Marine Museum contents based at Washington, DC and the Quantico museums.



Harry Simes, F/2/29 has advised that Major General Charles D. Mize, USMC (Ret) has passed away. General Mize was a 2nd Lt. and was wounded in June, 1945, while serving as a Platoon Leader in F/2/29. He later served in the Korean conflict as a company commander with the Fifth Marines and was awarded the Navy Cross and the Bronze Star Medal. Continuing his Marine Corps career, General Mize eventually became commander of the 1st Marine Division, a post he held until retiring in 1976.

Rest in peace, general. You served your country well...

Hugh C. Becker, H and S/3/15, has written that he was known as "Pippen 3" in the 3rd battalion, 15th. "We were in direct support of the 29th in their initial attempts to take Sugar Loaf Hill," comrade Becker writes. "And like the other 3 battalions we laid down a lot of fire prior to each morning's assault by the infantry. I also remember the last two counter-attacks by the Japanese, in which we had to stop firing, as one gun from another battalion was firing short. One day after the island was secured, Lt. Calloway, Lt. Shank and I drove back to the original beach-heads — Red I and II. We passed Sugar Loaf and to this day wish we'd gone over and walked on that beat-up hill massacre."

"It would have been like standing on Little Round Top at Gettysburg..."



Dear Mr. Bush;

I was deeply saddened at the passing of Chaplain Donald W. Mayberry, as I had the good fortune to serve as his aide, but more so as his personal bodyguard, from the time we were with the First Provisional Marine Brigade and the 6th Division until our last tour in Tsingtao, China. He was a fine, exceptional clergyman who thought nothing of his personal safety so long as he could tend to the wounded and dying.

From Brigade Headquarters, prior to D-Day, 7/21/44 on Guam, he asked permission of General Shepherd to transfer from our ship, the USS Polk, to LST 478, so he could be with one of the first landing units. We had to use a command boat to get us alongside an amtrac heading for the beach. We were almost shot out of the water by enemy artillery, but made the landing on Yellow Beach 2, then were pinned down by enemy crossfire for what seemed like many hours. But that didn't stop Chaplain Mayberry, who continued to seek out the wounded and dying. I have never witnessed someone who seemed to dare the enemy to come at him.

On Okinawa, once again, Chaplain Mayberry tended to those in need, moving from one position to another, so that even I didn't know exactly where we were. In the accompanying photo, the Chaplain and I decided to move out, when he found a Japanese bible in the little house of worship. We were the only two there and observed a movement in the hedge row. I immediately aimed my carbine and was about to fire, when we heard a voice shout out: "Don't shoot, I'm Len Eyerman, Life War Correspondent." It seems he was lost, too, but took our picture and mailed it to me after the war. I had the pleasure of visiting with Chaplain (then Reverend) Don Mayberry and his wife in San Francisco in 1985, and only wish I'd have had more time to be with him.

Rev. Mayberry was a life member of our association and I hope his wife will receive a marker for his tombstone. Her address is: Mrs. Natalie Mayberry, 361 14th Avenue, San Francisco, CA 94118.

Gathered some information that many "Old Warriors" who were members of the 4th Marines might be interested in, so I'm passing it along in case you can use it.

We, all of us, regardless of what unit we served with during WWII, hold one or two items in our memory that we have never forgotten. Most are remembered because they were exceptionally bad, but there were, on very rare occasions, a few that were never forgotten because they were good to recall to mind, and to periodically savor the warmth that they brought to our lives, having survived the battles.

Several pages of the "History of the Sixth Marine Division" are devoted to the initial landing in, the disarming of, and the occupation of the Tokyo Bay Area. It also touches on the release of Marine Prisoners of War that were taken at the fall of Wake Island and Corregidor. Many of these men so released had been members of the

original 4th Marines. When my grandchildren ask me to tell about the war, and they do ask, I find that I always speak of that gathering of Marines, the "Old" and the "New," so to speak, at the Naval Base at Yokosuka. It was, in the opinion of this "old Warrior," an experience of a lifetime, and certainly the best of the war years.

On May 18, 1999, the survivors of that group will meet in San Antonio, Texas, for another of their periodic assemblies. The Command Post will be at the Radison Hotel, Downtown Market Square, 502 West Durango Street, San Antonio, Texas, 78207. Phone (210) 224-7155. As "outsiders," common courtesy demands that permission to attend be granted, so Pat Hitchcock was contacted at 195 Windemere Circle, Jackson, TN, 38305 and I have been granted permission to attend the assembly. You might have received a number of letters about your Editor's Note to Edward W. Knebel concerning General Simon B. Buckner's service affiliation. Here's another one. It is not meant as a criticism. You do an excellent job as editor of the newsletter.

Gen. Buckner was an Army general. At the time of his death he was the commander of the Tenth Army, which was composed of the XXIV Army Corps and the III Amphibious Corps.

The III Amphibious Corps included the First, Second and Sixth Marine Divisions. The XXIV Army Corps included the 7th, 27th,

77th and 96th Infantry Divisions.

General Buckner was the grandson of Simon Bolivar Buckner, a Lieutenant General in the Confederate Army during the Civil War.

A neighbor of mine, who has since passed away, was a member of A-1-8 of the Second Marine Division. He had been wounded on Saipan and evacuated to the United States and so was not with his company on Okinawa when Gen. Buckner was killed. Buckner was with members of A-1-8 on the south end of Okinawa on June 18, 1945 when a rock fragment from an exploding shell struck him in the chest.

Buckner was the Commander of the Fifth Amphibious Corps. I think that your memory has failed you on this one. Gen. Simon Buckner, United States Army was Commanding General, United States Tenth Army.

The Marine Amphibious Corps at Okinawa was the III and was Commanded by Major General Roy S. Geiger, USMC. General Geiger was promoted to Lt. General and was appointed Commanding General, Tenth United States Army upon General Buckner's death. General Buckner was killed by enemy artillery fire on 18 June, 1945. General Buckner had instructed his Chief of Staff to inform Admiral Nimitz that upon his death he wanted General Geiger to have command of the Army until an Army General of suitable rank could be sent in.

General Geiger was promoted to four star rank many years after his death and was the only Marine General to Command an Army. Keep up the good work and Semper Fidelis.

Thoughts while shavin'

Adistinguished favorite son of old Savannah is till being honored and remembered by the city's civic and veterans associations, even though he died

on June 25 last year. Perhaps you've never heard of this man, and you probably didn't even realize that he considered himself the commanding officer of the "77th Marines." In July of 1994 he even returned to Guam for the 50th anniversary of Guam's liberation.

His name was Army Major General Charles Leon Davis and here's what happened: In the battle for the Otote Peninsula, then Lt. Col. Davis was instrumental in bringing devastating artillery fire from his own 77th Army Division to break a path for assaults by the First Provisional Marine Brigade and stop a last ditch Japanese banzai charge in its tracks. Army and Marine artillery, working together, poured 26,000 shells in the pocket of enemy attackers, often screaming as they attacked. At daylight, the muddy ground in front of the Marine positions was slick with blood. More than 400 bodies were sprawled in the driving rain. The General recalled how warmly individual Marines congratulated the effective role played by the 77th Artillery. They began calling them the "77th Marines."

The 77th went on to Leyte in the Philippines and then again, fought beside the Marines on Okinawa. It was known by all those who fought alongside the 77th as a good and effective outfit, with fine leadership and excellent spirit.

And to his dying day, Army Major General Charles Leon Davis was proud to be dubbed the C.O. of the "77th Marines."

So as Paul Harvey would say: "Now you know the rest of the story..."



In Bevan Case's History of the Sixth Marine Division, page 144, there appears a picture, with the caption "A veteran of the 22nd Marines." It is actually Harry Kizirian, known to some of his comrades as "The Beast" for his tenacity in combat.

On page 183 of the same publication,

those awarded the Navy Cross are listed, and here's what it says about Comrade Harry: Corporal Harry Kizirian, a squad leader with Company E, 2nd Battalion, 22nd Marines. While returning from a dangerous patrol in enemy territory, Corporal Kizirian had almost reached his lines when he spotted a Marine stretcher party pinned down by intense Jap fire. Despite wounds suffered in both legs and the groin, Corporal Kizirian held a heavy Browning Automatic Rifle in the crook of his arms and dragged himself in the direction of the enemy by pressure of his elbows. Firing a steady stream into the enemy position, he completely wiped it out, allowing the stricken group of Marines to gain their lines."

The same Harry Kizirian, a member of our association, living in Rhode Island, was recently visited by Past President Buzzy Fox, where this picture of the two old salts was taken. Buzzy reports that Harry was the Postmaster at Providence, R.I. for over 30 years until he retired. He is now Rhode Island's most decorated Marine.

I have always had a deep respect for men of the cloth — those individuals who shepherd us on our journey through life and try to keep us from straying too far from the fold. Most are underpaid, overworked and expected to solve all the problems that some families ought to be solv-

ing themselves. One of those men is our own chaplain, Claud Wilkins.

Claud was president of this association about 15 years ago, having served with us in WWII and the Korean War. Twenty years ago he began volunteering at the Methodist North Hospital in Memphis. "I was looking for something to do that was less hazardous," he said of the job. As of last September he has put in 9,000 hours of service to this hospital. He helped organize the very successful volunteer program during that time, devoting most of his Saturdays to this work, never mind his arthritic foot.

Claud has been on call for various services and reunions that the association has each year, such as the memorial service for Gen. Jim Day as well as others. When Past President Cliff Gilbert succumbed to cancer last year, Claud Wilkins traveled to Missouri to do the obituary and eulogy for our departed comrade at his funeral on Dec. 21. In February Claud was on hand at the Punchbowl National Cemetery for the placing of our memorial marker, which many of you attended And at all reunions, Claud capably conducts the Memorial Service.

Yet another side of this man is his help with amateur football teams. He was presented with a plaque and award by the National Football Foundation and College Hall of Fame, for his contribution to amateur football.

His work at the hospital does have some lighter moments. Like the time an elderly woman said to him, "You're such a nice man. Can't you get a better paying job?" And the patient whom he had just rolled back to his room from the lab, who joked, "You people are so great. I don't have to lie out in the hall for two hours with my rear end sticking out."



I'll bet you didn't know that the memorial marker that was set in the Punchbowl Cemetery arrived at Hickam Air Force Base with a Marine escort. Unofficial, but nevertheless, escorted. Here's the story in a letter from our good buddy, Harry McKnight and his wife, Barbara, who live in Columbus, Ohio.

The "Screaming Meemie"

"It has been said that all things come to he who waits, and I have waited and wondered since the day I received the newsletter relating to the story about the "Screaming Meemie" — a span of 54 years.

I was there in that courtyard when that thing hit. On 5 June, 1945, I was ordered to Bn Hq to get the code for my SCR-300 radio (it changed every day). As I entered the courtyard, there was a guy bent over a heat pellet with a canteen cup in his hand. Before I could speak to him, that Screaming Meemie came out of nowhere. It blew me and 38 lbs of radio over the courtyard wall.

One man was lying near the entrance of the tomb and I remember seeing another man in the doorway and that heat pellet lying on the ground still smoldering.

I managed to pull myself up far enough to see over the wall. One man was lying near the entrance of the and tomb remember seeing another man in the doorway and that heat pellet lying on the ground still

smoldering. I must have passed out after that, and when I came too, I was in a hospital ship offshore.

I have wondered and often thought about the poor guy who lost his leg. I don't think I will ever get over the smell of things that day and I keep seeing that heat pellet. Why??

A few years ago I read a book by Bill Manchester in which he relates about that terrible day in June. It brought back many memories and some things I couldn't remember, but not as vividly as Tim Joyner's article. I'm still not sure of all the facts and events—I'm not sure I ever will be.

Perhaps I will be able to talk to some guys who were there and the blanks will be filled in.

MONUMENTS & MEMORIES

We are pleased to announce that the design of the memorial, revised to accommodate the lower budget, has been reviewed and heartily approved by the National Cemetery System in Washington. It is completely in keeping with their requirement of landscape compatibility and presents a clear focus. It will leave a strong impression on those who visit.

The memorial will abut the Raider Memorial at the top of the Memorial Pathway, with a path connecting the memorial to the Memorial Pathway.

The entrance is flanked on either side by end stones. One stone (on the right) will carry a plaque with an explanation of the 6th Marine Division. The other will bear

the poem "Monuments & Memories," by Bob Gannon.


The form of the memorial is based on Okinawan structures. Two areas principally define this form. The first is a square open forecourt. The second is an inner circular contemplation court. A low continuous bench at the memorial perimeter will be formed to define this configuration. The seatbacks of the forecourt will have bronze plaques with the battlesites of the 6th Marine Division and its predecessor units. The plaque for Okinawa would be on the back seat at the head of the circular court. At the center of the inner court floor will be a large bronze plaque with the 6th Marine Division insignia. Radiating from this insignia are thin bronze inserts set into the concrete walking surface. These will tie the two courts together.


The floor will be CIP concrete with a decorative finish. The benches forming the overall contour will be precast concrete.

Paintings of American holly will flank the entrance and forecourt areas, the spiny nature of the leaves being representative of the great hardships and losses endured. The circular court will be surrounded by Mountain Laurel, this being conducive to a space for remembrance and contemplation.

Construction will be completed by fall. Formal dedication is planned for April 2000.

A Born Leader to the Corps

CAMP PENDLETON-When his fouryear stint as commandant ends June 30, Gen. Charles Krulak said here yesterday, he will leave the Marine Corps in better shape than when he took over and he will leave with the memory of the character of individual Marines imprinted on his soul.

Krulak made his last visit to Camp Pendleton as commandant yesterday and met with about 2,000 officers and senior enlisted Marines, telling them his 35 years in the Corps was "a great run." He said he is leaving "pumped and excited" about his future.

"I don't know what I will do for a job. I want time to kick back. Then I would love to work with youth," either as a teacher or by developing a national program for young people, Krulak said.

June 30 will mark the end of a formidable dynasty in the Corps: the first time in 70 years that a Krulak has not worn the eagle, globe and anchor, he said. Krulak's father, Victor, of Point Loma, is a retired three-star general.

He said he would like Marines to remember him as "someone who loved them and did his best to make the Marine Corps better. I will take with me the dedication of the men and women who put on this uniform (and) their unbelievable self-lessness that is found nowhere else."

Krulak compared himself to a football lineman, "someone who works in a non-glamorous position." That job has included tussling with Congress to wring extra dollars for programs, equipment and pay for

Marines.

When he testified recently before the House Armed Services Committee, Krulak said, he told the lawmakers, "You cannot pay my Marines enough for what they do for this nation. But you sure as heck can pay them too little."

The difference between civilian and military pay is partly to blame for a sharp decrease in enlistments in all services except the Marine Corps. But paychecks already have begun to grow, reflecting part of what is a proposed 25 percent increase in base pay between now and the beginning of 2005, Krulak said. That is a big deal, the top Marine told his troops, because base pay is what their retirement is calculated on. Those who entered the service after 1985 should have a better retirement for another reason as well.

Their retirement pay is proposed to be 50 percent of their final base pay, plus inflation adjustments, just as it has been for those who entered in 1985 or earlier. Previously, those who came in after 1985 were to receive 40 percent of their final pay in retirement. "You'll still be smelly and dirty and you're going to deploy and it's going to be rough, but you are getting more money," Krulak said.

A potential new benefit, which is also yet to be approved by Congress, would allow Marines who stay in for 20 years to transfer their GI Bill education money to their children

Krulak said he knows the importance of

such a plan because, after sending children to the College of William and Mary and Rice University, "I don't have the money to buy the material to build a flea a wrestling jacket."

Pay raises weren't the only good news Krulak brought with him. In June, Marines will begin receiving the long-awaited V-22 Osprey, a tilt-rotor aircraft seen as the replacement for aging Vietnam-era CH-46 helicopters. The same month, the Marines will take delivery of advanced amphibious assault vehicles that cut through water at 30 knots and will contain biological-chemical warfare protection for crew and passengers.

Other equipment gained during Krulak's tenure includes new boots, which are finally beginning to dribble in after manufacturing delays, and improved coldweather gear.

Of great pride to Krulak, he said, is that the Marine Corps has refused to lower its standards and still has repeatedly exceeded recruiting goals, while other services have lowered theirs and still can't meet their goals.

At a recent gathering of business leaders and politicians in Georgia, Krulak said, former Secretary of Education William Bennett told the assembly: "There is only one institution in the nation that holds to its standards, the Marine Corps." That, Krulak told his troops, is a credit to them and what they do daily. "Sneak off someplace where no one will see you being happy and pat yourselves on the back," he said.

One thing that hasn't gone well, though not through the fault of anyone here, Krulak said, is the education of Marines and other service members about the need to take anthrax vaccine to protect against biological warfare or terrorist attack.

"People are petrified that their penis is going to fall off, yet it is the safest vaccine ever given to American citizens. The polio vaccine was far more dangerous, yet the public lined up to get it," Krulak said.
