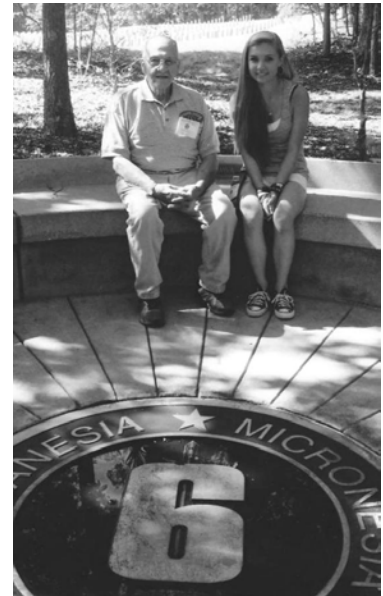

Remarks by Russell Scherck

2013 Reunion Banquet

August 17, 2013



Good Evening. I'm honored and humbled to be addressing an audience of my parent's generation, a generation about whom Tom Brokaw coined the term "Greatest Generation," and more specifically the Marines of the 6th Marine Division. Thank you. To be here at the National Museum of the Marine Corps where past, present, and future Marines gather is fitting.

Bob McGowan and I had the privilege to be in the audience at the opening ceremony of this museum and to witness President George W. Bush present the Medal of Honor to the parents of Cpl. Jason Dunham. Cpl. Dunham was born on 10 November 1981 and was killed in Iraq at the age of 22 on 14 April 2004. Here is an excerpt from his citation: "Corporal Dunham wrestled the insurgent to the ground and in the ensuing struggle saw the insurgent release a grenade. Corporal Dunham immediately alerted his fellow Marines to the threat. Aware of the imminent danger and without hesitation, Corporal Dunham covered the grenade with his helmet and body, bearing the brunt of the explosion and shielding his Marines from the blast." Why do I mention a Medal of Honor recipient who was killed in Iraq almost 60 years after the Battle of Okinawa? While reviewing your history, the history of the 6th Marine Division, I could not help but be drawn to the citations of the seven Medals of Honor awarded after the horrific three month battle. Three of those Medals of Honor were awarded for the same unselfish act of courage shown by Cpl. Dunham to protect his fellow Marines. The brotherhood, camaraderie, teamwork, and faithfulness shown by you and your fellow WWII Marines live on today in our Corps. The example you set in the Battle of Okinawa became and continues to be the yardstick that our present and future Marines will be measured by.

So what was unique about the Battle of Okinawa as it relates to today?

- Was it that the 6th Marine Division was a composite of Marines, Soldiers, and Sailors? No, that is not unusual or unique; it was just the precursor of what today we call Combined Task Force.
- Was it the duration of the battle – nearly 12 weeks? Possibly, as no battle since then has been continuously as long as Okinawa. (The first Battle of Fallujah was 30 days.)
- Was it the fanatical way the Japanese fought, resulting in the highest casualty rates of WWII – with the use of suicide planes and boats, and no surrender on the ground? To me the answer is yes. The fanatic way the Japanese soldiers and sailors fought with the use of suicide attacks was a culture we Americans do not embrace or understand. It is the same culture of suicide attacks that we thought was unique to the Japanese of yesterday that has taken on the face of radical Islam with the 9/11 attacks and almost every day with suicide bombers. We in America and other western nations today do not understand this culture of suicide for a cause any more than you did in 1945. This uniqueness is the single biggest lesson we should have learned from the Battle of Okinawa; one that we are still learning today.

This is pointed out in the book "Ripples of Battle" by Victor Davis Hanson whose uncle, Victor Hanson, Jr., 29th Marines, 6th Marine Division, was killed in action on Okinawa. Here is a tribute to you from the author. *[See page 8 for the letter from Victor Davis Hanson that Russell read.]*

Remarks by Russell Scherck (cont.)

Three weeks ago my wife and I were visiting friends who live near the small town of Roxboro, NC. While there, our hosts took us to the town museum. From that visit to the museum I learned two things that stayed with me about Roxboro: 1) Enos Slaughter, Hall of Fame baseball player who played for the St. Louis Cardinals and New York Yankees was raised there, and 2) so was PFC Thomas V. Rattican, 4th Battalion, 15th Marines, 6th Marine Division, who was killed in action on Okinawa. Your legacy lives on, not only with your families, close friends, and museums across America, but in the everyday actions of our Marines of today.

In closing I am going to read your Presidential Unit Citation:

The President of the United States takes pleasure in presenting the PRESIDENTIAL UNIT CITATION to the SIXTH MARINE DIVISION, REINFORCED

For extraordinary heroism in action against enemy Japanese forces during the assault and capture of Okinawa, April 1 to June 21, 1945. Seizing Yontan Airfield in its initial operation, the SIXTH Marine Division, Reinforced, smashed through organized resistance to capture Ishikawa Isthmus, the town of Nago, and heavily fortified Motobu Peninsula in 13 days. Later committed to the southern front, units of the Division withstood overwhelming artillery and mortar barrages, repulsed furious counterattacks and staunchly pushed over the rocky terrain to reduce almost impregnable defenses and capture Sugar Loaf Hill. Turning southeast, they took the capital city of Naha and executed surprise shore-to-shore landings on Oroku Peninsula, securing the area with its prized Naha Airfield and Harbor after nine days of fierce fighting. Reentering the lines in the south, SIXTH Division Marines sought out enemy forces entrenched in a series of rocky ridges extending to the southern tip of the island, advancing relentlessly and rendering decisive support until the last remnants of enemy opposition were exterminated and the island secured. By their valor and tenacity, the officers and men of the SIXTH Marine Division, Reinforced contributed materially to the conquest of Okinawa, and their gallantry in overcoming a fanatic enemy in the face of extraordinary danger and difficulty adds new luster to Marine Corps history, and to the traditions of the United States Naval Service.”

A Letter of Thanks from Victor Davis Hanson

The letter below was written by Victor Davis Hanson to the Marines of the Sixth Division on the occasion of their annual reunion at Quantico. Russell Scherck read this letter at the Reunion Banquet.

Victor Davis Hanson is an American military historian, columnist, former classics professor, and scholar of ancient warfare. He has been a commentator on modern warfare and contemporary politics for National Review and other media outlets. He is the Martin and Illie Anderson Senior Fellow at Stanford University's Hoover Institution. He is the author of some 250 articles, book reviews, and newspaper editorials on Greek, agrarian, and military history and essays on contemporary culture.



Victor Davis Hanson was named after his uncle, Vic Hanson of Fox Company, who was killed on Okinawa on May 18, 1945.

To the Veterans of the Sixth Marine Division

The United States owes a great deal of appreciation to you of the 6th Marine Division who suffered so much and fought so gallantly in the nightmare of Okinawa to defeat a fascist system that had a quite different—and quite evil—vision of what life should be like on both sides of the Pacific. Because the Marines of the 6th Division were so competent and courageous, they ensured the defeat of Imperial Japanese forces in the last great—and in some ways the most brutal—of the battles that America fought against the Axis powers.

In some sense, at a terrible cost, you not only helped to free us from the specter of the Japanese nightmare, but also liberated the Japanese themselves from their own criminal government. The postwar prosperity and friendship between Japan and the United States—made possible only through the victory of U.S. Armed Forces—that followed from the sacrifices on Okinawa is the legacy of the 6th Marine Division.

Finally, I owe special thanks to the veterans of 29th Marines, who shared the ordeal of my namesake Victor Hanson, Jr., and whom, in a fortuitous way, over sixty years after Victor's death, I had the opportunity to know, even if vicariously, from reading about them in his letters home. I grew up with constant stories of the character and integrity of Victor, who even at a young age had been the pride of a small agrarian Swedish-American family in Kingsburg, California.

My father, the late William F. Hanson, who flew on 40 missions on a B-29 over Japan and its territories, tried to explain to us even as children what Victor and his Marine comrades had done in Okinawa, and devoted his life to living up to Victor's ideals. I have tried my best as well, according to my lesser station, and wish again on this occasion to extend my appreciation to the Marines of the 6th Division for entering the inferno in a manner that few Americans could endure or indeed even contemplate—and emerging victorious, albeit at a frightening sacrifice on our behalf that you have all borne so nobly in the decades since.

President Connie Houseweart called the meeting to order at 7:00 p.m. and welcomed everyone. President Houseweart appointed Andy Sinatra and Dick Roberts as Sergeant at Arms.

Roll Call: The following officers were present: President Connie Houseweart, President Elect (and Immediate Past President) Sam Petriello, Secretary Lisa Benedetti, Treasurer Sharon Woodhouse, Chaplain Harry McKnight, Editor Carroll McGowan, Judge Advocate Bob McGowan, Service Officer Dick Roberts. Membership Chairman Jim White and Past President Ed Marsalek were absent and excused. The following Unit Directors were present: Ozzie Aasland (15th Marines), Bob Russell (22nd Marines), Jack Rice (6th Medical Battalion), Marvin Gromley (6th Pioneer Battalion), and Dick Roberts (6th JASCO). The following Unit Directors were absent: George Scott (4th Marines), Henry B. Kemp (29th Marines), Burr Allen (6th Engineering Battalion), Sal Mistretta (6th Tank Battalion), Joe Singleton (6th Recon Co.), and George Tremblay (1st Amphibs). Secretary Benedetti declared a quorum was in attendance (at least 30 members).

Proof of Meeting Notice: President Houseweart stated that the Meeting Notice was published in the spring and summer issues of the Striking Sixth. Secretary Benedetti had a copy available.

Judge Advocate Bob McGowan led the Pledge of Allegiance. Chaplain Harry McKnight gave the invocation.

Approval of Minutes of September 21, 2012:

Walter Mears, seconded by Harry Grover, moved to approve the minutes of the September 21, 2012 Annual Meeting as published in the winter issue of the Striking Sixth. All in favor, motion carried.

REPORTS OF OFFICERS AND UNIT DIRECTORS

President Connie Houseweart: Connie said she has enjoyed her year as president and it has been an honor to serve.

President Elect Sam Petriello: No report.

Secretary Lisa Benedetti: The Annual Meeting Minutes of September 21, 2012 will be signed and filed now that they have been approved.

Treasurer Sharon Woodhouse: The report covered the period of October 1, 2012 to July 31, 2013 (see page 17). Total assets @ 7/31/13 were \$55,808.99. Total assets @ 8/15/13 were \$56,591.01, which did not include many of the expenses for the reunion yet.

Bob Russell, seconded by Marvin Gromley, moved to approve the Treasurer's Report. All in favor, motion carried.

Chaplain Harry McKnight: Chaplain McKnight asked to be given names and addresses of members who may be in assisted living or nursing homes so that he can make contact with them.

Editor Carroll McGowan: The summer edition of the newsletter was recently sent out. President Houseweart mentioned that Carroll has saved the Association over \$800 since taking over as

Editor, as she does the design work herself. The transition from Joe Singleton to Carroll has been seamless.

Judge Advocate Bob McGowan: No report.

Membership Chairman Jim White: President Houseweart reported for Jim White. Jim would like to continue as Membership Chairman, if nothing else is done with this position and Flo Dornan is retained as Membership Manager. He is proposing amending the bylaws to eliminate the Membership Chair as that position does not really do anything. This matter will be taken under consideration later on the agenda under New Business.

Public Relations - Vacant: President Houseweart stated that Bill Pierce had resigned earlier in the year due to some health issues. Larry Walker has agreed to take over this position and he is part of the slate of officers to be presented for election.

Service Officer Dick Roberts: Grave markers are available for those who may need them.

Immediate Past President Sam Petriello: No report.

Past President Ed Marsalek: No report.

Unit Directors: Bob Russell asked the 22nd Marines to meet him after the meeting. Jack Rice, 6th Medical Battalion, commented that the Corpsman are fading away. He presented a check for \$500 for the scholarship fund in honor of the late Reverend Frank Mack.

REPORTS OF COMMITTEES

Nominations Committee: The Nominations Committee was made up of Sam Petriello, Ed Marsalek and Tiffany Woodhouse. Sam Petriello presented the slate of officers for 2013-14 as follows: President – Sam Petriello, President Elect – Connie Houseweart, Secretary – Lisa Benedetti, Treasurer – Sharon Woodhouse, Chaplain – Harry McKnight, Editor – Joe Singleton (Acting Editor Carroll McGowan), Judge Advocate – Bob McGowan, Membership Chairman – Jim White, Public Relations Officer – Larry Walker, Service Officer – Dick Roberts.

2013 Reunion: President Houseweart reported that the 2013 Reunion Committee consisted of President Connie Houseweart, Secretary Lisa Benedetti, Judge Advocate Bob McGowan, Acting Editor Carroll McGowan, and Treasurer Sharon Woodhouse. Sharon reported there are 37 veterans and 74 guests for a total of 111 people here this year.

Membership: President Houseweart reviewed the Membership Manager's Report. As of August 5, 2013 there are 2,271 names on the roster, which included all the categories. The number of paid subscriptions has risen due to the letter sent out in the spring regarding the fact that all subscriptions must be paid in order for anyone to receive the newsletter. Subscriptions to the newsletter are separate from membership dues. The Membership Manager's Contract for 2014 will remain at \$300 per month. The Board of Directors approved the contract.

Annual Meeting Minutes (cont.)

Bylaws Committee: Bob McGowan had no report.

Scholarship Committee: Bob McGowan reported that about 12 scholarships were awarded. The names will be published at a later date. Right now these scholarships extend to grandchildren of the WWII Marines.

Finance Committee: Sam Petriello reported the committee met August 15, 2013 pursuant to Article X (9) of the Bylaws of the Association. The books were reviewed and the committee found that the financial records and reports appear to be in order.

NEW BUSINESS

Lineal Descendants Oath: Chaplain Harry McKnight stated that he would like to administer an oath he prepared for the lineal descendants to take in honor of their relative who was a member of the 6th Division Marines. He asked all lineal descendants to stand and take the oath. He distributed membership cards to lineal descendants.

Presentations for Reunion 2014: Sharon Woodhouse stated that the Holiday Inn offered the Association the 2013 rates to come back in 2014 for the reunion. The hotel would store the boxes with all the flags and other items of the Association, and that would save shipping costs that are incurred each year. The first two weeks of October are open. There are various excursions that could be set up for next year too. The current reunion committee felt this was a viable idea to present to the membership as there were no other proposals received.

Barb McKnight stated that she had offered to host the reunion in Columbus, Ohio last year and would do so again for 2014 as an alternative. She had no cost particulars, but believed they would be similar to the Quantico area. There is a lot to do in the Columbus area and there is a major airport there.

A show of hands was taken for each proposal and Quantico was chosen as the 2014 Reunion site.

Proposal to Bylaws: Sam Petriello explained that he is proposing combining the Membership Chair position with the Treasurer, since the Membership Manager works closely with the Treasurer, and Jim White, the current Membership Chair, feels the position does not have any duties.

Watson Crumbie explained what Jim White meant in his email. He thinks the office of Membership Manager should be made permanent with Flo Dornan in that position. Watson also thinks the Service Officer should be eliminated, as it has no responsibility, except to store the large memorial markers, which are now obsolete. The Chaplain can send condolence letters and a small memorial marker. Bill Pierce will give the Association the small memorial markers. Watson would like to propose an amendment to the Bylaws. He noted that because this amendment to the Bylaws was not previously published, the vote would have to be unanimous for the motion to pass.

Watson Crumbie, seconded by Dick Whitaker, moved to eliminate the office of Service Officer. Vote taken by raising of hands. As it was not unanimous, the motion failed and the amendment was not adopted.

Watson stated that the next motion was on behalf of Jim White, Membership Chair. He would like to see Flo Dornan made the permanent Membership Manager and the Membership Chair be eliminated. He again noted that the vote would need to be unanimous for the motion to pass.

Watson Crumbie, seconded by Ed Cotten, moved to eliminate the position of Membership Chairman and make the Membership Manager a permanent office of this Association.

Bob McGowan explained that the Membership Manager is a paid position for which Flo is paid \$300 per month and she does a great job. There has been discussion about the rate, and if this position is made permanent then a rate scale would need to be set. He would vote against it, because it needs to be thoroughly thought out. He believes it should be put in the newsletter with discussion and a vote taken next year. Sam Petriello read the Membership Chairman's duties from the Bylaws, which is to keep track of members and take their dues. Most of the financial duties are now done by the Treasurer. Mrs. Dornan does a great job as Membership Manager, but she is the only one who has the records, and the Membership Chairman should also have a copy per the duties in the Bylaws. Sam stated that he thinks two people should have the records of the membership in case something happens to the Membership Manager. Also two people should know how the records are kept. He believes the Treasurer should have a second copy. Watson Crumbie stated he has a backup of the records. Sam replied that he knows he does, but he has not given them to the Treasurer. Sam would be willing to propose an amendment in the newsletter to combine the offices of Membership Chair and Treasurer.

President Houseweart stated Sam's proposal of eliminating the Membership Chair and combining it with the Treasurer, but still keep the Membership Manager. Helen Simmons seconded the motion. A vote taken by raising the hands was asked for, but there seemed to be too much confusion as to what was being voted on.

Bob McGowan stated that there was a motion on the floor made by Watson Crumbie to eliminate the Membership Chairman's position and make the Membership Manager a permanent office of the Association. Watson reiterated that this was based on Jim White's recommendation.

A voice vote was taken and since the vote was not unanimous, the motion failed.

Bob stated this proposal would be published in the newsletter so a vote could be taken at the next Annual Meeting.

Bob then asked Sam if he wanted to continue with a vote on his proposal. Sam stated he will submit the amendment for publication in the newsletter so it can be voted on at the next Annual Meeting.

Sam asked Watson what the date of the last update was and Watson replied that while he did not have a date, it was recently. Watson Crumbie commented that he did not think that two people could manage several thousand records. He believes that just one person should do so, and the Membership Manager should continue to handle the membership records. Bob McGowan reiterated that Flo Dornan does a tremendous job as Membership Manager and everyone agreed.

Annual Meeting Minutes (cont.)

Appreciation Award: Watson Crumbie said he took over the Membership Manager's position in St. Louis for one year before Flo took over. During this year, an Editor was needed and Joe Singleton was the only one to offer. He was Editor for 12-13 years. Watson proposed a proclamation or plaque of appreciation for Joe. All were in favor of this happening, and President Houseweart stated she would take care of it.

Officer Elections: Lisa Benedetti read the officer nominations listed above under the Nominations Committee Report and stated that all had accepted. President Houseweart asked if anyone else was interested, as nominations could be taken from the floor.

David Mears, seconded by Dick Whitaker, moved to accept the nominations and vote. All in favor, motion carried.

President Houseweart asked for nominations of two members at large to serve on the Nominations Committee for 2014.

Anita Benedetti, seconded by Al Benedetti, nominated Barb McKnight to be on the Nominations Committee and Barb accepted. David Mears, seconded by Marvin Gromley, nominated Tiffany Woodhouse to be on the Nominations Committee and Tiffany accepted. All in favor, motion carried.

Bob McGowan stated that he had contacted all of the Unit Directors from last year and they will stand again if there are no objections. The following Unit Directors were elected: 4th Marines – George Scott, 15th Marines – Ozzie Aasland, 22nd Marines – Bob Russell, 29th Marines – Neil McCallum, 6th Medical Battalion – Jack Rice, 6th Engineering – Burr Allen, 6th Tank Battalion – Sal Mistretta, 6th Pioneer Battalion – Marvin Gromley, 6th Recon Co. – Joe Singleton, 6th JASCO – Dick Roberts, and 1st Amphibs – George Tremblay. The 6th Motor Transportation Battalion and 6th Headquarters Battalion positions remain vacant.

Chaplain Harry McKnight gave the benediction. Adjournment was at 8:27 p.m.

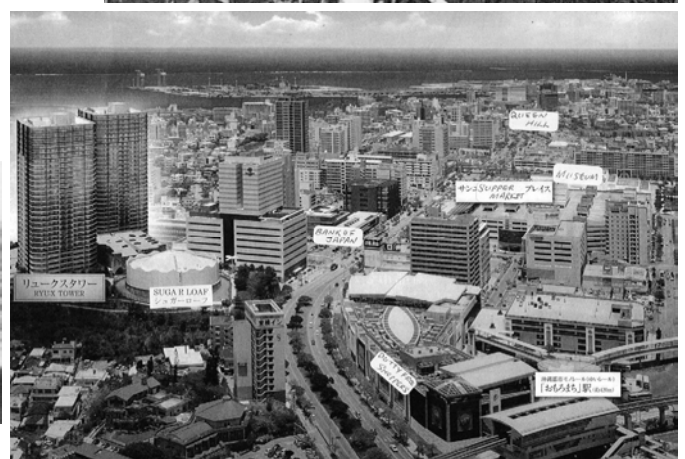

What a Hero Looks Like

Following is an editorial that appeared in the Wall Street Journal on July 30, 2013. George “Bud” Day was 17 in late 1942 when he badgered his parents into allowing him to volunteer for the Marine Corps. He spent nearly three years in the South Pacific during World War II.

After serving as a U.S. Marine in World War II, a normal man might have concluded that he had done more than his share of military service. And anyone still alive after his parachute failed to open upon ejection from an Air Force jet in the 1950s would consider calling it a military career. But Col. George E. “Bud” Day, who died Saturday at age 88, kept putting himself in harm’s way.

And that is why, at age 41, he was flying low over North Vietnam in August 1967. He led a command of forward air controllers — all volunteers because their mission of spotting enemy targets was so dangerous that nearly a quarter of their 155 pilots were shot down. Day’s F-100 was one of them, and he was captured and tortured.

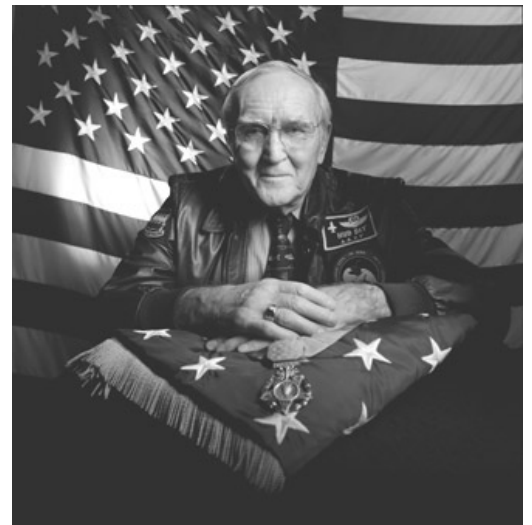
Despite severe injuries he escaped barefoot and fled through the jungle toward South Vietnam. Two days later an explosion tossed his body into the air, rupturing his eardrum and sinuses and tearing his leg with shrapnel. Yet he resumed his journey south, living off frogs and berries as he dodged Communist patrols. Roughly two weeks after his escape, he was in sight on an American base when a North Vietnamese soldier pointed a rifle at him. Day tried to escape again but was shot in the hand and thigh and captured.

Refused medical treatment and suffering infections, Day must have seemed ill-equipped to resist his captors. And yet through years of captivity he provided them only false information to avoid giving anything that might help shoot down more Americans.

His determination was a inspiration to fellow Americans at the infamous “Hanoi Hilton” prison. In February 1971, Day and several others were discovered hold-

ing a forbidden religious service. According to the Air Force, “As the guards burst into the meeting room with rifles pointed at the prisoners, one of the Americans stood to his feet. Ragged, battered but unbroken, it was George Day. Looking into the muzzles of the enemy rifles he began to sing.”

The song was the Star-Spangled Banner, and one by one other prisoners joined in the song. James B. Stockdale, who sang along that day and like Day would win a Medal of Honor, would recall, “Our minds were now free and we knew it.”

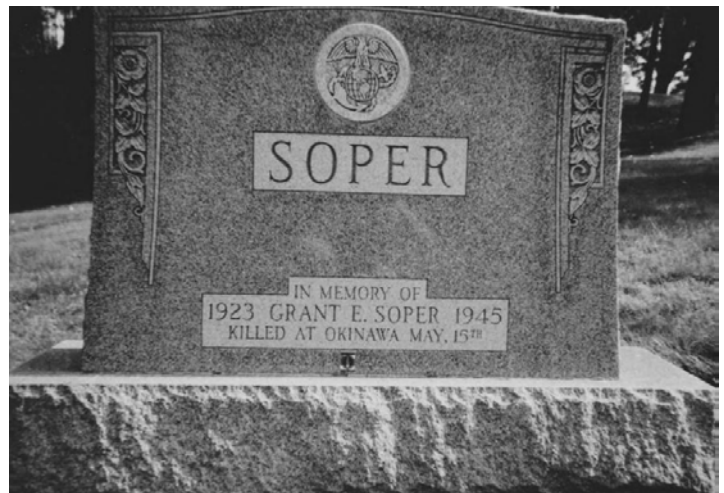
Searching for My Dad's Buddies

My Dad was a squad leader in the 3rd Platoon, H/3/29. All my life I heard about my Dad's men who were killed on Okinawa, most of them on May 14, 1945 in one costly assault on a little hill off to the left flank of Sugar Loaf. Like most Marines, my Dad spoke of them by their last name only; Soper, Martin, Laney, Pallo and so forth. As far back as I can remember, I knew that my Dad's best buddy was Corporal Soper. I knew that they shared a fox hole and that Soper was killed on the same day my Dad and most of their platoon were killed or wounded. I knew that when my Dad scrounged "Ten and One" C-rations from the Army that eleven rations spread among the 13 Marines left two guys hungry, my Dad and Soper. That made a big impression on me as a kid. A Marine feeds his men first, and his buddy would rather go hungry with him than eat in front of him.

After my Dad died in 1999 I started trying to locate his buddy. I saw from the Honor Roll in the History of the Sixth Marine Division that his full name was Grant Elmer Soper. I searched online and found a Grant Soper that was born in Poughkeepsie, NY in 1923. I wrote the local library and they sent me a copy of an article and a picture that was published after his parents were notified of his death. I registered Grant in the Registry of the WWII Memorial, and shortly after that I was contacted by Pat Soper, Grant's niece. She told me that Grant was one of four boys, three of whom fought in WWII, including Pat's father Roy. I arranged to meet Pat and her husband Jim Zeleniak to tell them what I knew of Grant and what happened on 5/14/45. After my Dad was gravely wounded, he gave Grant command of the squad, which was down to three men. Before Dad crawled into a tomb and passed out, the last thing he saw was Grant and PFC Josephus Judge going over the top of the hill. They never came back.

Pat told me where Grant was buried and later that year I made my way to Poughkeepsie to pay my

respects. As I drove past the rivers and streams of the Mid-Hudson Valley, I thought of how my Dad would have loved to visit Grant after the war to hunt and fish and have a beer or two. The cemetery was beautiful. The staff drew me a map to Grant's grave and I headed over there. From a distance I could see the name SOPER carved in a large headstone with a big Eagle, Globe and Anchor. I affixed one of the small 6th MARDIV emblems at the base, saluted, and then I called Pat. I can't remember what we said, but I think we both cried. I know I did. As I was standing there, two Mallard ducks went flying past, haulin' ass. ENLISTED ON 12/9/43. TRAINED AT PARRIS ISLAND, SOUTH CAROLINA AND PUERTO RICO. STATIONED AT WASHINGTON D.C. FOR SIX MONTHS BEFORE JOINING THE SIXTH MARINE DIVISION. SERVED IN THE 1ST SQUAD, 3RD PLATOON, H COMPANY, 3RD BATTALION, 29TH MARINE REGIMENT. KILLED IN ACTION ON 5/14/45, WHILE PARTICIPATING IN THE ASSAULT ON SUGAR LOAF HILL.

My original entry also included "He was my Dad's best friend," but they edited that out for some reason; I have no idea why. But I'm here to tell you that it was the truth.

From the Historian's Corner

WHERE AND HOW TO SHARE YOUR WWII ARTIFACTS

Several people have recently asked: What is the proper place to share WWII artifacts? If a member of the "greatest generation" kept an item all these years, one knows that it must have been special to them... but what does one do with those items when a friend/parent/husband is downsizing or has passed away?

If arrangements have not been made for those items, here are a few ideas. One suggestion is to contact a local county/city museum and or library. They may be very interested in the items, especially if they are accompanied with a period picture of the person who owned them or one that ties him/her to the community. Another place might be the local Marine League. There is also the museum in Okinawa on Camp Kinser. Unfortunately, places like the National Museum of the Marine Corps get so many donations that unless an item has some very special circumstance or was used by someone "famous," they don't seem to have much interest in them anymore.

Another possibility that is more personal, is creating a display for someone special in your family who will appreciate the significance of such a gift. In our family, both of my sons have special mementos passed to them by a member of Sixth that are not only treasured, but they can tell the history of them. Hence the story of the Battle of Okinawa continues. My daughter was also given an item and she proudly displays it in her first home. For items kept in families, make sure they are preserved in a way that they will not deteriorate, especially for pictures and papers. Here is a website that may be helpful with that:

Another place that can be helpful with pictures and papers is the GRC or Alfred M. Grey Marine Corps Research Center, which is located at Quantico. The archives already has a Sixth collection that I created. I have been told it is the best Division collection. The GRC supports the educational needs of the Marine Corps University, Marines worldwide, and other Marine Corps researchers (like me!). Here again, they are probably not interested in your "green book" (they have countless of them) or official Marine Corps pictures. However, unique

items—V-mail, personal pictures, diaries – are different. They also give historians a better picture of what the "regular guys" went through during that time. The address of the GRC is: Alfred M. Gray Marine Corps Research Center, 2040 Broadway St., Quantico, VA 22134

Preserving our past and the legacy of our families is a valuable and important task. I hope that members of the Sixth are sharing their 'sea stories' with a special young person, perhaps one who is not even a family member. I encourage you to write or tape record your experiences, and I hope you know that there are people out there who care very much about the freedoms that you allowed us to continue to enjoy.
